
In producing here with 07 accd persons namely (1) Rohan Mahato(53) S/O-Chamari Mahato of Vill-Jodhadih More Chas, PS-Chas, Dist-Bokaro, Jharkhand (2) Parmanand Kr Mahato(21)S/O-Shibu Mahato of Vill-Bandhdih, PS-Katras, Dist-Dhanbad, Jharkhand (3) Mithun Mahato(22)S/O-Aklu Mahato of Vill-Arsha, PS-Arsha, Dist-Purulia (4) Rama Sankar Singh (39)S/O-Kedar Singh of Vil-Maniyar, PS- Tiyar, Dist-Bhojpur, Bihar (5) Munna Kr Yadav(29) S/O-Lt Shivjee Yadav of Vill-Narayanpur, PS-Bihiya, Dist-Bhojpur, Bihar (6) Hanif Sk (38) S/O- Lt Nedar Bokso Sk of Vill-Koladanga, PS-Daulatabad, Dist-Murshidabad, WB (7) Rabiul Islam(30) S/O-Imani Sk of Vill-Chaighori Bramanpara, PS-Daulatabad, Dist-Murshidabad, WB along with seized articles i.e. 04 (four) vehicles having registration Nos (1) JH10V/9513 loaded with approx 25 TN coal (2) WB 81/0658 loaded with approx 24 TN coal (3) NL 01AD/1105 loaded with approx 29 TN coal (4) WB 57C/6100 loaded with approx 25 TN coal, seems to be steam coal and also taken sample of 05 kg from each truck to the effect that I along with C/1335 Nirmal Kr. Mahato, C/330 Banamali Soren, and NVF/1535 Pravas Ruhidas all are of Hura P.S were engaged in mobile duty vide Hura P.S CC No 2683/22 Dtd 22.11.2022 at about 18.05 Hrs in course of mobile duty received a credible source information that four vehicle loaded with illegal coal were coming from Purulia side . After receiving information contacted with my O/C and informed the matter and as per kind order myself accompanied with force immediately proceeded towards the Vehicles and managed to stop the vehicles at Hura Hattola on 23.11.2022 at about 07.05 hrs, on seeing the police party 06/07 persons were tried to flee away but somehow we are managed to apprehend the above noted persons. On asked they failed to produce any valid documents in respect of loaded coal. Accordingly, I arrested them after observing all formalities regarding arrest and seized the above noted vehicles loaded with coal under proper seizure list duly signed by the accompanied police persons as there was no availability of any local person, as such I could not collect the signature of the local people in all seizure list.


On preliminary enquiry it could be learnt that they were procured the said illegal coal from different places and transporting the same in a clandestine manner to another district/state.

So, it is reasonable to believe that they were transporting the coal illegally after procuring. Accordingly made proper arrangement and brought the seized coal at PS to keep at PS compound.

Therefore, I pray that a specific case may kindly be registered against above noted arrested persons, driver and owner of the 04 (Four) seized vehicles and other associates under proper section of law.
