**Sir,**


In producing here with one arrested accused namely Bapi Hari (28 Yrs) S/O Hiralal Hari of Vill- Hattagram, P.S- Indpur, Dist- Bankura,, along with seized vehicle No. WB 67 A 6687. I beg to report that on 04.11.22 I SI Jayanta Chakraborty along with C/711 Duagapada Barik, C/1446 Alok Ranjan Lohar and C/330 Banamali Soren were performing night mobile duty vide Hura PS C.C No - 2527/22 dtd. 04.11.2022 and Hura PS GDE No.161 Dtd-04.11.2022, while we reached at Bispuria more under Hura PS area at about 23.05 hrs. We found that one Truck having Registration No WB 67 A 6687 was coming from Hura side towards Bankura side with rash and negligently. We tried to stop him but the driver of the said vehicle named noted above was trying to escape the place dangerously, there was every possibility of loss/ serious injury of nearby public due to his such dangerous driving. After a hot chase we could be able to stop him at near Niyasa Border) under Hura PS, Purulia at about 23:25 hrs. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. On demand he failed to produce any valid documents in respect of the said vehicle and stated that the all documents kept into owner of the said vehicle. Accordingly, I seized the above noted vehicle by preparing seizure list (details are mentioned in the attached seizure list) with a view to prosecute him U/S 279 IPC. The whole process of seizure was completed in between 23:35 hrs and on 05.11.22 at 00:25 hrs. I also arrested driver of the said vehicle as he violated sec 279 IPC in presence of Police party. During the time of arrest maintained all formalities regarding arrest.

Hence I pray that a specific case U/S 279 IPC may kindly be initiated against accused Bapi Hari (28 Yrs) S/O Hiralal Hari of vill- Hattagram, P.S- Indpur, Dist- Bankura, driver of vehicle No. WB 67 A 6687 (Tata Truck) and arrange its investigation.


