Sir,

In producing here with one arrested accused person namely Amit Kumar Mahato (19) S/O Rathulal Mahato of Vill- Turdag, PO-Karmadih, PS-Jhalda, Dist-Purulia and brought under seizure one Black and Blue colour Hero Splendor Plus Motor Cycle bearing Reg. No- JH 01CZ 0626 before you.

1 SI Sujit Das of Jhalda PS do here by lodged a written complaint against Amit Kumar Mahato (19) S/O Rathulal Mahato of Vill- Turdag, PO-Karmadih, PS-Jhalda, Dist-Purulia to the effect that today (09/11/2022) while performing Spl. mobile duty (This refers to Jhalda P.S. GDE No- 411 Dt- 09/11/2022, in consonance with C.C. No- 2629 Dt- 09/11/2022) along with force namely 1) HG/1681 Manmatha Kumar 2) HG/1772 Fatik Ch. Kumar both of Jhalda PS in PS area. As per your order, I started MV checking at Ichag more near SBI Bank on Jhalda Bagmundi Road (SH-4) after placing guard rail. During MV checking at about 15.05 Hrs I detained one Motor Cycle coming from Jhalda Town side driving so rash and negligently which was identified as dangerous driving with two pillion riders. The rider and the two pillion riders were without wearing protective headgear that could be identified as the dangerous driving of any motor vehicle. Subsequently Lintercepted the said motor cycle having Reg. No- JH 01CZ 0626. On interrogation the rider having the control of the motor vehicle disclosed his identity as mentioned above and on asking the pillion rider of said motor cycle disclosed their identity as Mohit Mahato (19) S/O Jogeswar Mahato of Vill-Udaysiry, PO-Karmadih, PS-Jhalda, Dist-Purulia and Bhiksakar Mahato (19) S/O Abinash Mahato of Vill- Dulla, PO-Ichag, PS-Jhalda, Dist-Purulia. As the rider of the motor vehicle having control could not give satisfactory reason of his rash and negligent driving which could be taken into consideration as dangerous driving. Subsequently, I seized the said motor cycle and arrested the rider having control of the motor vehicle for violating the Sec-279 IPC & R/W Section-184/194D/194C MV Act after maintaining all the formalities as well as guidelines of Hon'ble Supreme Court and NHRC regarding arrest.

I, therefore pray before you to start a specific case against accused rider having control of the motor vehicle namely Amit Kumar Mahato (19) S/O Rathulal Mahato of Vill- Turdag, PO-Karmadih, PS-Jhalda. Dist-Purulia U/S 279 IPC & R/W Section-184/194D/194C MV Act and arrange for its investigation.
