Sir.

In producing here with arrested accused persons namely 1) Andip α Renga Chitrakar (22) S/O Madhab Chitrakar of Vill-Dewandera, PS Kotshila, Dist-Purulia & 2) Ramjan Kazi (42) S/O Sahaban Kazi of Vill- Hussendih, PS-Jhalda, Dist-Purulia and seized articles (i) One Iron Rod length approx 4 ft (ii) one bamboo stick length approx 4.5 ft (iii) One Bhujali attached with Bamboo handle length approx 1.5 ft and sharp edge of Bhujali is approx 5 inches (iv) one lylon rope in red colour length approx 20 mtr lodged complain against them and 15/16 others 1) Bhalka S/O Sk Manu 2) Saddam S/O Sk. Kamrul 3) Sk Afzal @ Batla S/O Sk Mansur 4) Istaque @ Anna S/O Budruddin all of Vill- Kantadih, PS-Jhalda, Dist-Purulia were among them to the effect that on 10.11.2022 at about 23.15 Hrs during my night mobile duty received a credible tip that a gang of dacoits being armed with deadly weapons assembled under a Palash tree in a patch of Jungle situated near the Satyamela Maidan under Gokulnagar Mouza and they were preparing themselves for committing dacoity at Jhalda Town. Subsequently I, informed to you as well as the Duty Officer and as per your direction I asked the duty officer to note the information down in the GDE Vide Jhalda PS GDE No 496 Dated 10.11.2022. On getting the tip off as per kind order myself accompanied with force who were detailed for the Night Mobile Duty with me namely (i) C/1284 Pratapaditya Majhi, (ii) C/214 Siddhartha Mandal, (iii) HG/1772 Fatik Ch Kumar & (iv) NVF/778 Samir Ch. Mahato all of Jhalda PS vide CC No. 2644 dated 10.11.2022 & vide Jhalda PS GDE NO 491 Dated 10.11.2022 immediately proceeded to the anticipated place of assembly to work out the information and reached near Mayasarobar at 23:45 Hrs leaving the Police vehicle No- WB 56C 8741 and started to proceed for the anticipated place on foot. At 23:55 Hrs reached at anticipated place laid on ambush and we noticed in a glimpse of light that 17/18 persons assembled under a Palash tree in a patch of Jungle situated near the Satyamela Maidan 100 mtr away from Mayasarobar and those persons are whispering from which it was clear that they are preparing themselves to commit dacoity as it could be audible from the parlance of the assembled criminals. We cordoned them very cautiously. Then after disclosing our identity, I commanded them to surrender but they did not pay any heed and tried to flee away. We succeeded to nab in rounding up only 02 (two) of them at 00:05 Hrs while the rest 15/16 had managed to escape despite of a hot chase after them. They disclosed their identity as mentioned above. We told them we want to search them if necessary they can search us, but they told they are not willing to search us, then after observing all formalities I searched the above noted apprehended persons and recovered the following articles from the exclusive possession of the respective accused person (i) One Iron Rod length approx 4 ft (ii) one bamboo stick length approx 4.5 ft from the possession of Andip @ Renga Chitrakar, and (i) One Bhujali attached with Bamboo handle length approx 1.5 ft and sharp edge of Bhujali is approx 5 inches (ii) one lylon rope in red colour length approx 20 mtr the possession of Ramjan Kazi. Subsequently, I seized in between 00:25 hrs to 01:15 hrs on 11.11.22 from the place of assembly of the accused persons and from the possession of the above noted apprehended persons, after observing all formalities, (i) One Iron Rod length approx 4 ft (ii) one bamboo stick length approx 4.5 ft (iii) One Bhujali attached with Bamboo handle length approx 1.5 ft and sharp edge of Bhujali is approx 5 inches (iv) one lylon rope in red colour length

approx 20 mtr from the place of assembly under proper seizure list as well as label duly signed by apprehended persons and witnesses as Alamat. On interrogation they confessed their guilt and they stated that they have assembled there with 15/16 others, 1) Bhalka S/O Sk Manu 2) Saddam S/O Sk. Kamrul 3) Sk Afzal a Batla S/O Sk Mansur 4) Istaque at Anna S/O Budruddin all of Vill-Kantadih, PS-Jhalda, Dist-Purulia were among them for committing a house dacoity in a Maru family at Jhalda Town. I am to note here that I have to conduct search & seizure in presence of Police Witnesses as because as it was dead hour of night and it was a lonely place, so I could not able to accompany with public witness. Under such circumstances it is reasonable to believe that the above noted apprehended persons were assembled there for committing house dacoity. So, after observing all formalities I arrested those persons after preparing memo of arrest and ground of arrest duly communicated to them.

Therefore, I pray that a specific case may kindly be registered against the arrested accused persons namely 1) Andip @ Renga Chitrakar (22) S/O Madhab Chitrakar of Vill-Dewandera, PS- Kotshila, Dist- Purulia & 2) Ramjan Kazi (42) S/O Sahaban Kazi of Vill-Hussendih, PS-Jhalda, Dist-Purulia along with 15 others, 1) Bhalka S/O Sk Manu 2) Saddam S/O Sk. Kamrul 3) Sk Afzal @ Batla S/O Sk Mansur 4) Istaque @ Anna S/O Budruddin all of Vill- Kantadih, PS- Jhalda, Dist- Purulia were among them and others under proper section of law.
