Respected Sir,

In producing here with 01(One) arrested accused person namely Chutubabu Kumar (35) S/O Gopal Kumar of Vill- Chekya, PS- Kotshila, Dist- Purulia and along with seized 01(one) Tractor having Registration No- WB 55B 5375 attached with sand loaded trolley approx 100 cft . The fact in brief is that on (20/11/2022) I along with force namely (i) C/214-Sidhartha Mandal (ii) C/331-Manasharam Kumar (iii) NVF/1036-Promotho Kuiry were performing evening mobile duty in PS area vide Jhalda P.S. GDE No- 936 Dated- 20/11/2022 in consonance with Jhalda PS CC No- 2751/22 Dated- 20/11/2022. During my evening mobile duty I received credible source information that one Tractor was lifting & carrying sand illegally and coming from Ichag side towards Jhalda Town. Subsequently, I informed you and as per your gracious order, I placed Naka at on Jhalda Bagmundi pitch road at near Gokulnagar village to work out this tip off and started Naka Checking after proper placing guard rail on Jhalda Bagmundi pitch road at near Gokulnagar village. Thereafter I saw the one Tractor was proceeding towards Jhalda Town. Consequently, we intercepted the said Tractor at before Naka checking point on 20/11/2022 at about 19:05 hrs and found that the vehicle as well as goods as identical as I received prior information. But seeing the Police Party driver who was on that vehicle (Tractor) started to flee away. After hot chase we managed to apprehend him. On being asked, the driver of the vehicle disclose his name noted in the supra. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded with sand trolley. But the driver of the said vehicle could not able to produce any kind of documents in respect of the Tractor and the sand loaded trolley. I repeatedly asked the driver to produce the valid papers but he stated differently in different times. The incoherent statement of the driver purported to be a suspicious to us. It was ascertained that the driver of the Tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So it is reasoned to belief that he in cahoots with the owner of the vehicle procured the said sand from Subarnarekha River from Shyamnagar Ghat by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo I, seized the Tractor having Registration No- WB 55B 5375 attached with sand loaded trolley (Approx 100 cft) under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver namely Chutubabu Kumar (35) S/O Gopal Kumar of Vill- Chekya, PS- Kotshila, Dist- Purulia after informing the ground of arrest and issued Memo of Arrest against him. Thereafter, I brought the said Tractor to Jhalda PS compound.

Under the above facts and circumstances kindly take lawful action against the driver namely Chutubabu Kumar (35) S/O Gopal Kumar of Vill- Chekya, PS- Kotshila, Dist- Purulia and the Owner of the said vehicle as they committed an offence U/S 379/411/414/120B of the IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957.
