Sir,

In producing herewith one arrested accused person namely Uttam Gope (26 yrs) S/o-Sudhir Gope of Vill- Gawaladih PS-Joypur, Dist-Purulia under arrest along with seized articles as per seizure list i.e. (1) One white colour polithin Jariken containing approx 09 (Nine) liter illicit liquor (locally known as Mohulla) (2) 15 pieces glass under proper seizure with label

I, SI Mahadeb Rana of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that on today 12/11/2022 at about 15:15 hrs when myself along with NVF-1021 Bablu Mahato, HG/45 Abedan Ansary were performed Special mobile-II duty vide Joypur PS C.C. No-3880/22 date-12/11/2022, as per my source information I reached at Patharchatam Dungi near Gawaladih Village under Joypur PS and found that the above noted accused person selling illicit liquor (Mohulla) in the hut of Uttam Gope S/o-Sudhir Gope of V.I.-Gawaladih PS-Joypur, Dist-Purulia. On seeing Police person, he conceal his presence at that place, but on searching we able to trace out him and also to found that 09 (nine) liter of illicit liquor (locally known as Mohulla) which was kept at his hut. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling illicit liquor to the local people in the area. On demand he failed to produce any valid documents in respect of selling such illicit liquor (Mohulla). So it is reasonable to believe that he was selling the ld liquor (Mohulla) illegally without any documents. So I seized the same under proper seizure list in between 16:35 hrs to 16:50 hrs & label duly signed by him and other available witness after taking 600 ML as sample in a separate bottle.

During further interrogation he confessed his guilt as such I arrested him today 12/11/2022 at 16:55 hrs as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Uttam Gope (26 yrs) S/o-Sudhir Gope of Vill- Gawaladih PS-Joypur, Dist-Purulia U/S-46A (c) of the Bengal Excise Act 1909
