Sir,

In producing herewith one arrested accused person namely Kalipada Mandal (36 yrs) S/o-Paltan Mandal of Vill-Jahajpur PS-Joypur, Dist-Purulia under arrest along with seized articles as per seizer list i.e. (1) 02 (two) white colour plastic Jariken containing approx 25 (Twenty five) liter Illicit liquor (locally known as Mohulla) (2) One Hero Splendor Plus Black & Blue Colour Motor Cycle bearing Regd. No-JH09AG-9727 under proper seizure with label.

I SI Mahadeb Rana of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that on today 19/11/2022 at about 15:25 hrs when myself along with C/-1234 Mantulal Mandal C/-894 Dhananjoy Mandal NVE/-817 Bhubaneswar Mahato were performed evening mobile duty vide Joypur PS C.C. No-3979/22 date-19/11/2022 received credible source information that one person coming from Jahajpur village side to Khedatard village with one Motor Cycle loaded with approx 25 (Twenty five) liter Illicit liquor (locally known as Mohulla). I reached nearby Khedatard village more under Joypur PS to work out the source information. We stop the Motor Cycle and found that approx 25 (Twenty five) liter Illicit liquor (locally known as Mohulla) he carrying with his Motor Cycle bearing Regd. No-JH09AG-9727. On seeing Police persons, he tried to fled away in the concealed place, after hot chase we able to apprehended him. On search found approx 25 (Twenty five) liter Illicit liquor (locally known as Mohulla) hanging his MC with a plastic jarican. On being asked he disclosed his name and address as noted above. On interrogation he stated that he will selling illicit liquor (locally known as Mohulla) to the local people in Khedatard village area after collecting from other side but on demand he failed to produce any valid documents in respect of selling such illicit liquor (locally known as Mohulla). So it is reasonable to believe that he was selling the Id liquor illegally without any documents. So I seized the same under proper seizure list in between 17:05 hrs to 17:25 hrs & label duly signed by witnesses after taking 01 liter of illicit liquor (locally known as Mohulla) as sample out of 25 (twenty five) liter.

During further interrogation he confessed his guilt as such I arrested him today 19/11/2022 at 17:30 hrs as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Kalipada Mandal (36 yrs) S/o-Paltan Mandal of Vill-Jahajpur PS-Joypur, Dist-Purulia U/S-46A (c) of the Bengal Excise Act 1909.
