


Most respectfully begs to state as follows: -

- 1. That the complainant as well as accused person are permanent resident of Vill.Mukundapur under P.S.Joypur, Dist. Purulia within the jurisdiction of Honourable court.
- 2. That the complainant and his wife Kamala Gorain unfortunately parents of the Nimai Gorain were residing in the same premises which complainant purchased through his own income and prepared a house building therein by investing his all money earned by hard work from the service work and that house situated upon the R.S.Plot No.479, 480 total area 6 decimals.
- 3. That at the begning complainant, his wife and three sons started to residing on the aforesaid house and elder son already shifted to elsewhere by rude and rusty beviour of middle son i.e. accused Nimai Gorain since long.
- 4. That out of three sons, middle son Nimai Gorain is very dangerous and rude in nature and by taking advantage of old age, accused Nimai Gorain used to assault the complainant and his wife Kamala Gorain and lastly on 23.10.22 after assault mercilessly expelled the parents from the house by snaching all the valuable documents, papers of six deposit alongwith ornaments forcefully and commit extortion by putting the complainant and his wife in fear of death or grevious hurt and having no other alternative complainant and his wife reside elsewhere



with great fears and at any time the accused may commit any brutal work upon the complainmt.

- That prior to 23.10.22 accused used to blackmail 5. the complainant by taking his entire monthly pension money either by way of theft our robbed and having suffocation situation complainant called a meeting and all the village headman and other people take participate in that meeting and on 24.10.22 a written agreement prepared where it was settled and agreed that accused Nimai Gorain will be possess the western two houses and the eastern chalagarh, two vehicle i) Artica JH-10BZ-8160 and ii)Bolero Pick up WB55A-5735 and a motor cycle JH-10AH-4893 and accused assured to the complainant and another son, to whome some portion of the house were given for the purpose of ration shop, the accused will not disturb in future and also assured through agreement accused will not started any grocery business in the same premises to damage business of another son and possession of settled articles were given to the accused and in lieu of that accused will give Rs. 3000/-the per month for maintenance
- 6. That inventor of performing the written agreement accused sold the aforesaid two vehicle without taking consent of complainant and accused gave nothing which he agreed to give apart from that after lapse of few days from that agreement accused started grocery shop violating the term




terms and condition of the agreement and it is very much clear that accused cheated the complainant on the name of agreement.

- That recently accused giving the pressure to the complainant to transfer the ownership of the house and instead the name of the accused in all fixed deposit money by depriving the another sons and if the complainant disagree in that case accused will not allow to enter into the house to complainant and due to exterim old age and fear complainant his wife residing elsewhere with the manger of other.
- 8. That exp several occasion complainant informed the matter before the panchayat, village people as well as P.S. but as the accused is a very serious and criminalised in nature they did noting.
- 9. That accused also informed the matter through

 on 3.10.22 but till date did nothing.
- 10. That complainant is suffering from various act of accused by declaring cheating, extorm threatning for life and expelled from the house.
- 11. That accused is very influencial person and as the accused is suffering from extenmold age there is xevery



chance of recovery of documents as spectite the sec.

u/s. 156(3) Cr.P.C. is highly required to book the criminal as per provision of law.

It is therefore prayed that your Honour may graciously be pleased to accept this petition of complaint as F.I.R. and send this complaint petition before the O.C.Joy-pur P.S. for investigation and to take necessary action against the accused for the ends of justice.
