1) \_\_\_\_\_ That the complainant above named is a permanent resident of Village & P.O. Karkara, P.S. & Joypur ,Dist.- Purulia and within the jurisdiction of this Ld. Court.

2) \_\_\_\_\_ That on 12.10.2022 around 9.00 P.M. while the complainant keeping guard towards his fishery of "Bara Rakh" ponds at Village & P.O. Karkara, P.S.- Joypur, District- Purulia suddenly all the accused persons arms ~~watch~~ with iron rods sticks, sword etc. attacked the complainant and physically assulted him.

3) \_\_\_\_\_ That accused persons No.1 Akhtiar Chowdhury & accused peron No.3 Laden Shah snached Rs.4000/- ( Rupees Four thousand only ) from the pocket of the complainant. the accused no.3 Laden Shah and accused no.2 Rajababu Shah also brutally assaulted the complainant by fish and blow also kicked him by felling down on the ground. The accused persons also tried the complainant with a rope and forcefully steal away all the fishes from the complainant cultivated fishering at " Bararakh " pond as a result the complainant sustained financial losses amounting to Rs.40,000/- ( Rupees Forty thousand ) only.

4) \_\_\_\_\_ That the accused person also forcefully snatched away the mobile phone off the complainant and broke it by forcefully thrown it to the ground.

5) \_\_\_\_\_ That the complainant on the morning of 13.10.2022 went to Joypur P.S. to lodge ~~complaint~~ complaint about the incident but the reason best known to the duty officer who refused to lodged complaint against the accused persons.

6) \_\_\_\_\_ That on 14.11.2022 the complainant send his written complaint to the I.C. joypur P.S. through registered Post, but all in vain.

- 7) \_\_\_\_\_ That as on 28.10.2022 the complainant informed the matter to the S.P. Purulia but till date no action has been taken against the accused persons.
- 8) \_\_\_\_\_ That the accused persons now started to threaten the complainant with dire consequences as a result the complainant passes each and every day out of fear and mental agony.
- 9) \_\_\_\_\_ That having no other alternatives the complainant compelled to file this complaint petition U/s.156(3) of Cr. P.C. before this Ld. Court.

It is therefore that your Honour may graciously be pleased to admit this petition U/s.156(3) of Cr.P.C. and send it to the I/c Joypur P.S. w/ with a direction to investigate this case by treating the same as F.I.R. U/s.156(3) of Cr.P.C. and took proper step against the accused persons.
