The accused persons also tried the complainant with a rope and forcefully steal away all the fishes from the complainant cultivated fishing at " Bararakh " pond as a result the complainant sustained financial losses amounting to Rs.40,000/- (Rupees Forty thousand) only.

4) _____ That the accused person also forcefully snatched away the mobile phone of the complainant and broke it by forcefully thrown it to the ground.

5) _____ That the complainant on the morning of 13.10.2022 went to Joypur P.S. to lodge ~~complaint~~ complaint about the incident but the reason best known to the duty officer who refused to lodge complaint against the accused persons.

6) _____ That on 14.11.2022 the complainant send his written complaint to the I.C. joypur P.S. through registered Post, but all in vain.
