In producing here with 03 accused persons namely (1) Ashok Yadab (45 yrs) S/o-Dasarath Yadab of Vill-Fulartand PS-Madhuban Dist-Dhanbad State-Jharkhand (Driver of track No-JH09AC-1179) (2) Haroon Ansari (42 yrs) S/o-Late Sabar Ansari @ Miya of Vill-Maharajganj PS-Tundi Dist-Dhanbad State-Jharkhand (Driver of track No-JH10BU-7356) (3) Azad Ansari (35 yrs) S/o-Late Hussen Ansari of Vill-Murgaboni PS-Gobinpur Dist-Dhanbad State-Jharkhand (Driver of track No-JH10AA-7781) along with seized articles i.e. 03 (three) track having Registration No- (1) JH09AC-1179 loaded with approx 25 TN coal, (2) JH10BU-7356 loaded with approx 25 TN coal and (3) JH10AA-7781loaded with approx 25 TN coal also taken sample of 05 kg from each truck, to the effect that I, ASI Swapan Mandal along with C/-1358 Sanjib Patra, C/-985 Lakshan Ch Majhi & C/-2494 Biswanath Mahato all of Joypur PS Dist-Purulia vide CC No-4039/22 Dated-24/11/2022 were engaged in Naka checking duty at Kathaltard strategic point at Jharkhand Border on Purulia-Bokaro Pitch Road (NH-32) under Joypur PS Dist-Purulia and found the above noted track were coming from Bokaro side via NH-32 towards Kathaltard on seeing the Naka Checking party stop the Track and found that loaded huge quantity of illegal coal, they tried to fled away, after hot chase we able to apprehended 03 persons. On being asked they disclosed their name and address as noted above. On interrogation they stated that they will sell illegal coal to the local people at Chasmore under Joypur PS. On demand they failed to produce any valid papers in respect of possessing selling of coal. So it is reasonable to believe that the Driver & owner of the above noted track collected the said coal either by theft or by any other fraudulent means from anywhere and transporting the same to earn money for wrongful gains. As such, there is every reason to believe that the above noted track transporting coal illegally. So I seized the same under proper seizure list in between 22:45 hrs to 23:15 hrs & label duly signed by witnesses after taking sample of 05 kg coal from each track. During further interrogation they confessed their guilt as such I arrested them today 24/11/2022 at 23:25 hrs to 23:40 hrs as the accused persons is liable for prosecution U/S-379/411/414 IPC.

I therefore pray before you, kindly lodge an FIR against the owner of the Track (1) JH09AC-1179 (2) JH10BU-7356 (3) JH10AA-7781 and arrested accused driver (1) Ashok Yadab (45 yrs) S/o-Dasarath Yadab of Vill- Fulartand PS-Madhuban Dist-Dhanbad State-Jharkhand (Driver of track No-JH09AC-1179) (2) Haroon Ansari (42 yrs) S/o-Late Sabar Ansari @ Miya of Vill-Maharajganj PS-Tundi Dist-Dhanbad State-Jharkhand (Driver of track No-JH10BU-7356) (3) Azad Ansari (35 yrs) S/o-Late Hussen Ansari of Vill-Murgaboni PS-Gobinpur Dist-Dhanbad State-Jharkhand (Driver of track No-JH10AA-7781) as per law and arrange for its investigation.
