Sir,

In producing here with 02 accused persons namely (1) Mustfa Ali S/o-Wahid Ali (31 yrs) S/o- of Vill-Bahiyarkala PS-Ramna Dist-Garhwa State-Jharkhand (Driver of Track No-CG15AC/9083) Mob-9511434421 (2) Rabindar Yadav (37 yrs) S/o-Chana Yadav of Vill-Dundhibag Bazar PS-BS City Dist-Bokaro State-Jharkhand (Driver of track No-JH09AA-0752) Mob-8434815892 along with seized articles i.e. 02 (two) Track having Registration No- (1) CG15AC/9083 loaded with approx 25 TN coal, (2) JH09AA-0752 loaded with approx 25 TN coal also taken sample of 05 kg from each truck, to the effect that I, SI Nagendranath Das along with C/-997 Rajkumar Bauri, C/-842 Angshuman Tewari & NVF/-860 Suryakanta Mahato all of Joypur PS Dist-Purulia vide CC No-4054/22 Dated-25/11/2022 were engaged in Naka checking duty at Kathaltard strategic point at Jharkhand Border on Purulia-Bokaro Pitch Road (NH-32) under Joypur PS Dist-Purulia and found the above noted Tracks were coming from Bokaro side via NH-32 towards Kathaltard on seeing the Naka Checking party stop the Tracks and found that loaded huge quantity of illegal coal, they tried to fled away, after hot chase we able to apprehended 02 persons. On being asked they disclosed their name and address as noted above. On interrogation they stated that they will sell illegal coal to the local people at coal at any place of Purulia district. On demand they failed to produce any valid papers in respect of possessing selling of coal. So it is reasonable to believe that the driver & owner of the above noted Tracks collected the said coal either by theft or by any other fraudulent means from anywhere and transporting the same to earn money for wrongful gains. As such, there is every reason to believe that the above noted Tracks transporting coal illegally. So I seized the same under proper seizure list in between 21:25 hrs to 21:45 hrs & label duly signed by witnesses after taking sample of 05 kg coal from each Tracks. During further interrogation they confessed their guilt as such I arrested them today at 21:55 hrs to 22:05 hrs as the accused persons is liable for prosecution U/S-379/411/414 IPC.

I therefore pray before you, kindly lodge an FIR against the owner of the Tracks (1) CG15AC/9083 (2) JH09AA-0752 and arrested accused driver (1) Mustfa Ali S/o-Wahid Ali (31 yrs) S/o- of Vill-Bahiyarkala PS-Ramna Dist-Garhwa State-Jharkhand (Driver of Track No-CG15AC/9083) Mob-9511434421 (2) Rabindar Yadav (37 yrs) S/o-Chana Yadav of Vill-Dundhibag Bazar PS-BS City Dist-Bokaro State-Jharkhand (Driver of track No-JH09AA-0752) Mob-8434815892 as per law and arrange for its investigation.
