Sir,

In producing here with 02 accused persons namely (1) Md Salim Ansari (25 yrs) S/o-Md. Jahur of Vill-Raghunathpur PS-Katrasghar Dist-Dhanbad State-Jharkhand (Driver of Track No-JH10AA-6015) (2) Sek Sahid (35 yrs) S/o-Sabir Miyan of Vill-Raghunathpur PS-Katrasghar Dist-Dhanbad State-Jharkhand (Driver of Track No-JH10W-1385) along with seized articles i.e. 02 (two) Track having Registration No- (1) JH10AA-6015 loaded with approx 25 TN coal, (2) JH10W-1385 loaded with approx 25 TN coal also taken sample of 05 kg from each truck, to the effect that I, SI Manas Kumar Panda along with C/-516 Chandra Sekhar Mahato, C/-2217 Souvik Rana & C/-2497 Sandip Mandal all of Joypur PS Dist-Purulia vide CC No-4055/22 Dated-25/11/2022 were engaged in Naka checking duty at Kathaltard strategic point at Jharkhand Border on Purulia-Bokaro Pitch Road (NH-32) under Joypur PS Dist-Purulia and found the above noted Tracks were coming from Bokaro side via NH-32 towards Kathaltard on seeing the Naka Checking party stop the Tracks and found that loaded huge quantity of illegal coal, they tried to fled away, after hot chase we able to apprehended 02 persons. On being asked they disclosed their name and address as noted above. On interrogation they stated that they will sell illegal coal to the local people at coal at any place of Purulia District. On demand they failed to produce any valid papers in respect of possessing selling of coal. So it is reasonable to believe that the drivers & owners of the above noted Tracks collected the said coal either by theft or by any other fraudulent means from anywhere and transporting the same to earn money for wrongful gains. As such, there is every reason to believe that the above noted Tracks transporting coal illegally. So I seized the same under proper seizure list in between 10:45 hrs to 11:05 hrs on 26/11/2022 & label duly signed by witnesses after taking sample of 05 kg coal from each Tracks. During further interrogation they confessed their guilt as such I arrested them today at 11:10 hrs to 11:15 hrs on 26/11/2022 as the accused persons is liable for prosecution U/S-379/411/414 IPC.

I therefore pray before you, kindly lodge an FIR against the owners of the Tracks (1) JH10AA-6015 (2) JH10W-1385 and arrested accused drivers (1) Md Salim Ansari (25 yrs) S/o-Md. Jahur of Vill-Raghunathpur PS-Katrasghar Dist-Dhanbad State-Jharkhand (Driver of Track No-JH10AA-6015) (2) Sek Sahid (35 yrs) S/o-Sabir Miyan of Vill-Raghunathpur PS-Katrasghar Dist-Dhanbad State-Jharkhand (Driver of Track No-JH10W-1385) as per law and arrange for its investigation.
