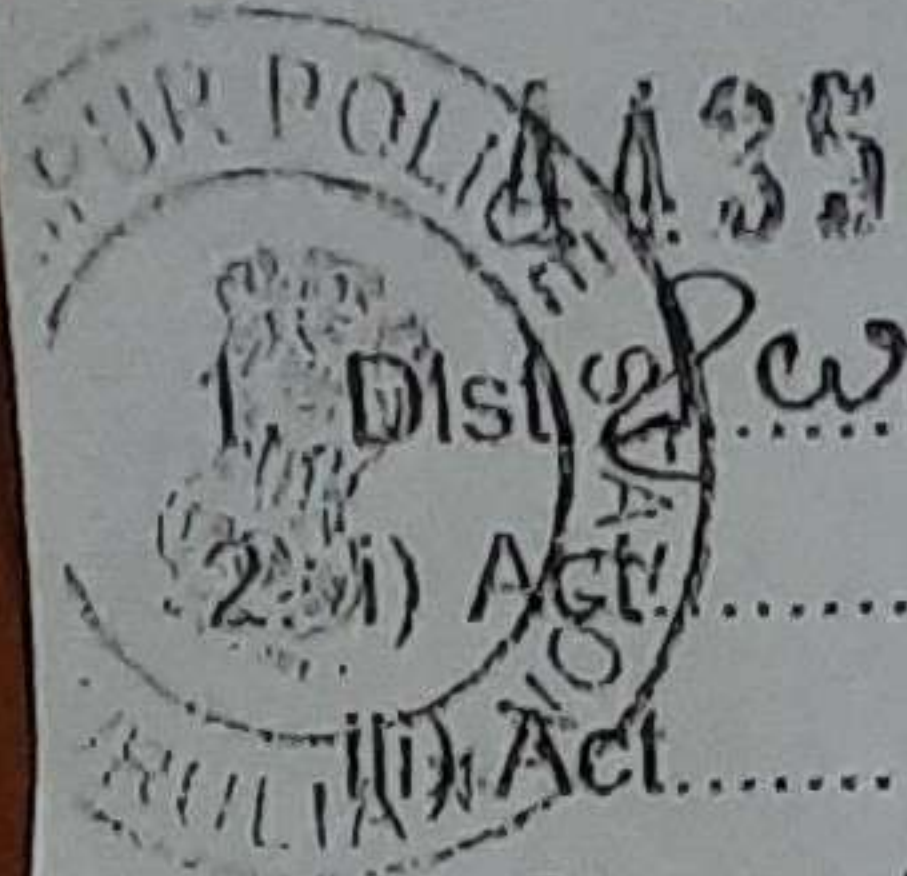

Sub: To lodge FIR against owner and driver of seized tractors i.e. (1) Mahindra B 275 DI (Red Colour) Tractor having Registration No WB 81/2120 along with trolley (without number plate) loaded with sand approx 60 - 65 Cft and (2) Powertrac 439 EI (Blue Colour) Tractor having Chassis No T053477251KJ and Engine No E3537328 along with trolley (without number plate) loaded with sand approx 80-90 Cft.

Sir,

In producing herewith 02 (Two) seized tractors i.e. (1) Mahindra B 275 DI (Red Colour) Tractor having Registration No WB 81/2120 along with trolley (without number plate) loaded with sand approx 60 - 65 Cft and (2) Powertrac 439 EI (Blue Colour) Tractor having Chassis No T053477251KJ and Engine No E3537328 along with trolley (without number plate) loaded with sand approx 80-90 Cft (3) 04 (Four) Belchas and (3) 04 (Four) Dhamas.

The nub of the fact in a nutshell is that on 11.11.2022 at 08.25 hrs I ASI Shibram Bauri of Kashipur PS along with (i) C/1256 Anadi Dhibar and (ii) C/693 Jayanta Singh Sardar both of Kashipur PS, Dist -Purulia, left the PS for performing day mobile duty at Kashipur P.S area vide Kashipur P.S GDE No 433 dtd - 11.11.2022 and C.C No. 2978/22 Dtd. 11.11.2022. During my mobile duty, I received a tip off at 12.25 hrs that some persons were loading two tractors with sand from the river bed of Darkeswar River near Jagannathdih village under Kashipur P.S. Subsequently, I along with force moved to the spot. We kept the vehicle on the bank of river and proceeded towards the spot by foot. We kept the vehicle on the bank of river and proceeded towards the spot by foot. We came to find that few persons were loading sand in the attached trolleys of said tractors. Seeing the Police party, those persons leaving the tractors (loaded with sand in the attached trolleys) at Darkeswar River and fled away from the spot. We rushed to the Tractors and detained the said tractors. We searched the said tractors and found that the tractors were loaded with sand and also searched surrounding but could not trace out the persons & drivers of said offending Tractors. Hence, I seized the above noted tractors along with trolley loaded with sand and other articles in between 13.05 hrs to 13.45 hrs and brought the said seized articles to Kashipur PS. As there is every reason to believe that the drivers and owners of the said tractors with ill motive were transporting sand illegally without any valid documents in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owners and drivers of above noted tractors along with the trolleys for investigation.


