In producing herewith arrested accused person namely Doctor Mahato (30), S/o-Bhagtu Mahato of village-Pendra, PS-Tamna, Dist- Purulia along with one seized Black colour Bajaj Discover Motorcycle bearing Registration No- JH 09 S 2874.

I beg to report that today myself along with C/922 Sanjoy Bauri, C/181 Rabban Sekh both of Kenda PS were performing Day mobile duty at Jamtal More under Kenda PS area vide Kenda PS C.C No-1159/22 dtd. 01.11.2022 and Kenda PS GDE No-1186 dtd-01.11.2022 at about 12:55 hrs, I found one Black Colour Bajaj Discover Motorcycle bearing Registration No- JH 09 S 2874 coming from Kenda Bazar side rashly and negligently. We try to stop him but the driver of the said motorcycle named in above was trying to escape the place rashly, so there was every possibility of loss/ serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger for human life.

So, I arrested him as he violated Sec. 279 IPC and also seized the motor cycle in presence of witnesses. His family member was also informed about the ground of arrest.
