Most respectfully begs to state as follows:-

ornaments ,utensils, bedding and furniture etc.
- 3.---That the marriage between them solemnized on  
23-10-2021 (4th day of Kartick 1428 B.S.) and after  
marriage the complainant along with those urniture were  
taken to her matrimonial home at village Kuldih under  
P.S.Kenda, Dist.Purulia.
- 4.---That the accused No.1 is the husband of the compit.  
and other accused persons are the mother-in-law, sister-  
in-law, father-in-law.
- 5.---That soon after the marriage the accused No.1 and  
other inmates of the house of Accused No.1 became hostile  
towards upon the complainant as items of doweries are not

are not upto mark and also taunted aiming the parents of the complainant relating to dowries, but the complt. tolerated the same without any protest and waited for a good day.

6.---That the ~~accused~~ accused No.1 and his family members drove her from their house on 19-04-2022 corresponding to 5th day of Baisakh 1429. Since then she is staying in her father's house at village Singh Bazar with utmost difficulties. And the accused No.1 did not take any information where about his wife.

7.---That the complainant has got no means to passing her livelihood.

8.---That the accused No.1 is one Driver and has Ten Bighas of cultivable lands and a good vegetable garden and from all sources his monthly income is more than Rupees Thirty thousand (Rs.30,000/-)

9.---That there after the matter was reported to Kenda P.S. but no case has been started against the accused persons, then the matter was reported to S.P.Purulia but off no good.

10.---That your petitioner is a female and the case requires through Police prove including examination of witnesses who are residents of different places seize article and documents etc.

It is therefore prayed that your Honour may graciously be pleased to direct the O/C Kenda P.S. to treat the petition as a F.I.R. U/s 156 Cr.P.C. to cause investigation in respect of alleged incident.

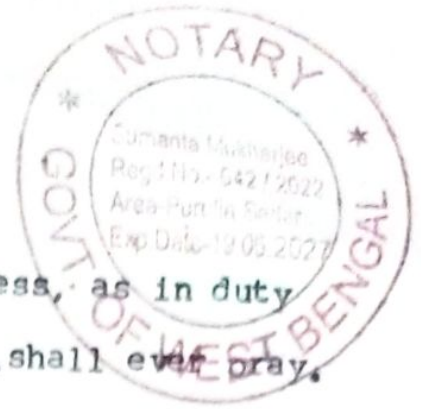
