Respected Sir,

In producing herewith arrested accused person namely Sujay Mahato (19), S/o- Shibaprasad Mahato of village-Murgadanga, PS- Khatra, Dist- Bankura along with one seized Black & Blue colour Hero Glamour Motorcycle bearing Registration No- WB 68AE 1113.

I beg to report that today myself along with C/346 Shaktipada Rajak, HG-1933 Lakhindar Mura both of Kenda PS were performing Day mobile duty at Jamtal More under Kenda PS area vide Kenda PS C.C No-1245/22 dtd. 19.11.2022 and Kenda PS GDE No-638 dtd- 19.11.2022 at about 12:15 hrs, I found one Black & Blue colour Hero Glamour Motorcycle bearing Registration No- WB 68AE 1113. coming from Kenda Bazar side rashly and negligently. We try to stop him but the driver of the said motorcycle named in above was trying to escape the place rashly, so there was every possibility of loss/ serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger for human life.

So, I arrested him as he violated Sec. 279 IPC and also seized the motor cycle in presence of witnesses. His family member was also informed about the ground of arrest.

Therefore, I pray that a specific case may kindly be start against accused Sujay Mahato (19), S/o- Shibaprasad Mahato of village-Murgadanga, PS- Khatra, Dist- Bankura
