I, SI Milon Manna, OC Kotshila PS alongwith ASI Sanjoy Dey, C/982 Shyamal Rajwar, C/1524 Krishna Ch Mahato returned to PS with following seized articles 1)One broken iron structure,2) Black colour powder (Wet), 3) Small pieces of burn papers under proper seizure list and do hereby lodged a complaint as suomoto against unknown miscreants to the effect that today (10.11.2022) at 09.35 hrs Duty officer ASI Subhas Ch Kaibartya received a source information to the effect that some unknown person / persons have kept one suspected device of explosive beside the house of Pintu Dan S/O- Rabindranath Dan of Begunkodar, P.S-Kotshila during anytime of 09/10.11.2022 night. The information was diarized by ASI Subhas Ch Kaibartya vide Kotshila P.S G.D.E No. 393 dated-10.11.2022 and accordingly myself, ASI Sanjoy Dey along with force of Kotshila PS with Govt. Vehicle No. WB 26C-7292 left for Begunkodar Village to work out the information. At about 10.15 hrs on 10.11.2022 we reached at Begunkodar village and found that one iron made round shaped pipe content with some suspicious elements beside the house of Pintu Dan S/O- Rabindranath Dan of Begunkodar, P.S-Kotshila. Then we cordoned the surrounding area. I communicate such information to the superior officers and contacted with Bomb Disposal Squad (BDDS), Purulia through Superiors. Later the team of BDDS, CID, Purulia Unit arrived there at 15.40 hrs and removed the suspected device from that place after maintaining SOP.

Then BDDS, CID, Purulia Unit disposed off the one suspected explosive device (Iron pipe and plates) at an open field at Hanslata village under Kotshila PS.

After the disposal by BDDS, CID, Purulia Unit they handed over the following remnants of suspected device and control earth which were seized by me under proper seizure list duly signed by my accompanying officer and forces as seizure witnesses and labeled it separately.

After doing all the necessary process, I returned to PS at 19:05 hrs today (10.11.2022) with seized articles 1)One broken iron structure,2) Black colour powder (Wet), 3) Small pieces of burn papers and handed over the seized articles to Malkhana Officer SI Ramu Gurung and started Kotshila P.S Case No. 156/2022, Dated-10.11.2022, U/S 3/4 of The Explosive Substances Act, 1908 against unknown miscreant(s).
