In producing here with 01(One) arrested accused person Mukesh Choubey (22) S/O Jitendar Choubey of Damra road. Asansol South District-Paschim Burdwan along with seized one TATA ACE Van Bearing Reg. No. WB37E/0238.

I beg to state that today i.e on 04.11.2022 in course of my day mobile duty vide Manbazar PS GDE No.144 dt. 04.11.2022 I had been to Indkuri more side at 14:45 hrs and found that the above noted person with his TATA ACE Van Bearing Reg. No. WB37E/0238 was coming from Pairachali side with excessive speed and rough driving in negligence manner without wearing seat belt.
