Sir,

In producing here with 01(One) arrested accused person Mukesh Choubey (22) S/O Jitendar Choubey of Damra road. Asansol South District-Paschim Burdwan along with seized one TATA ACE Van Bearing Reg. No. WB37E/0238.

I beg to state that today i.e on 04.11.2022 in course of my day mobile duty vide Manbazar PS GDE No.144 dt. 04.11.2022 I had been to Indkuri more side at 14:45 hrs and found that the above noted person with his TATA ACE Van Bearing Reg. No. WB37E/0238 was coming from Pairachali side with excessive speed and rough driving in negligence manner without wearing seat belt. Myself along with force signalled to stop him but the driver of the said vehicle drove speedily and disobediently and tried to flee away. Somehow we could be able to detain him near Indkuri more on Manbazar- Pairachali road under Manbazar PS. This rough and negligence driving of driver would lead to an accident at any time. Any passerby could be injured by such activities. On being asked the above accd. person could not be able to give any satisfactory answer for that movement on road and public place by such rough driving. So I arrested him at 15:05 hrs for rough and negligent driving and disobeying the order duly promulgated by public servant, after maintaining all rules of arrest, issued memo of arrest. So, I seized the said TATA ACE Van (White colour) Bearing Reg. No. WB37E/0238 in between 15:15 hrs to 15:25 hrs after preparing seizure list in presence of the witnesses duly signed by them.

So, a specific case may kindly be initiated against Mukesh Choubey (22) S/O Jitendar Choubey of Damra road. Asansol South District-Paschim Burdwan as per law and arrange for its investigation.
