Sub: Complain to start a specific case.

Sir,

In producing herewith one arrested accused person namely Ajoy Bouri (31 years) S/O- Dharamdas Bouri of Vill-Benipur, PS-Neturia, Dist-Purulia along with one seized TATA 207 Pick-up vehicle bearing registration No- WB 37A/6638 loaded with 1 ½ MT (Approx) raw coal, do hereby lodge a complaint to the effect that on 18.11.2022 I, SI Biswajit Banerjee, along with C/1319 Soumen Koley, C/564 Prasad Majhi and NVF/530 Dilip Singh all are of Neturia PS were engaged in evening mobile duty vide Neturia PS GDE No- 764 Dt. 18.11.2022 & CC No- 3678/22 Dt. 18.11.22. In course of evening mobile duty at about 18:45 hrs reached at Murgaboni More on Sarbari -Madhukunda pitch road. In the mean time at about 19:05 hrs found that the above noted vehicle was coming from Murulia side under Santuri PS towards Murgaboni side under Neturia PS. We indicated the vehicle to stop and on checking it was found that coal seems to be steam was loaded inside the vehicle. Then I requested the driver to produce relevant documents/challan/cash memo in respect of loaded coal but he failed to produce any valid documents in support of loaded coal as well as vehicle and also his driving license. On preliminary enquiry and as per statement of the restrained driver it could be learnt that he along with registered owner of the vehicle namely Sk. Insan S/O- Lt. Sk. Islam of Vill-Nimdanga, PO+PS-Neturia, Dist-Purulia have procured said coal from different illegal coal mines at different area.

So, it is reasonable to believe that the above noted accused driver and registered owner of the said vehicle have obtained the said coal either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same coal in a clandestine manner to Raghunathpur side knowing it to be stolen.

Accordingly, I seized TATA 207 Pick-up bearing registration No- WB 37A/6638 loaded with raw coal of 1 ½ MT (Approx) under proper seizure list duly signed by available witnesses and also I arrested Ajoy Bouri (31 years) S/O- Dharamdas Bouri of Vill-Benipur, PS-Neturia, Dist-Purulia (Driver) in this case. In course of arrest I notified him ground of arrest, issued arrest memo U/S-50 Cr PC and brought him PS with loaded TATA 207 Pick-up. I have also sealed & labelled approx 05 (Five) kg coal as sample from the major contraband on the spot.

Under the above circumstances a specific case may kindly be started against (1) Ajoy Bouri (31 years) S/O- Dharamdas Bouri of Vill-Benipur, PS-Neturia, Dist-Purulia (Driver) (2) Sk. Insan S/O- Lt. Sk. Islam of Vill-Nimdanga, PO+PS-Neturia, Dist-Purulia (Owner of the seized vehicle No- WB 37A/6638) under proper section of law.
