
With due respect I, ASI Dhaneswar Mahato of Neturia PS, beg to submit before you that on 19/11/2022 at about 17:05 hrs while myself along with force C/1302 Radhagobinda Dhibar and NVF/578 Niranjana Hembram were performing special mobile duty vide Neturia PS GDE No. 816 Date- 19/11/2022 at Sarbari More on Purulia-Barakar Road. I found one vehicle was coming from Raghunathpur side towards Barakar side with driving in excessive speed. Police personnel present there in proper Police uniform, raised hand and directed him to stop the vehicle but he violated the Police Signal and endangering human life by rash and negligently driving of the vehicle which may cause accident to the road user any time. After long chase we are able to apprehend him at Parbelia Bazar under Neturia PS. On interrogation he disclosed his identity as Vinod Ray (45 Years) S/O- Lt. Biku Ray of Manoharpur Arbinda Nagar, Ward No-11 Township, PS-Dankuni, Dist-Hooghly. On interrogation he stated that he is the driver of the vehicle. On being asked he failed to produce any valid documents of the said vehicle. Hence, he violated the provision of Section 279 IPC/184 MV Act. So, I seized the vehicle having Regd. No- WB 11B/9602 under proper seizure list duly signed by the witnesses and arrested the above noted offending driver abiding by all the procedure as laid down in Cr. P.C and the latest guidelines of the Apex Court.

So, I pray before you that a specific case may kindly be registered against the accused driver Vinod Ray (45 Years) S/O- Lt. Biku Ray of Manoharpur Arbinda Nagar, Ward No-11 Township, PS-Dankuni, Dist-Hooghly (Driver of vehicle having Regd. No- WB 11B/9602) committing offence U/S-279 IPC/184 MV Act.
