I do hereby submit complaint Suo-motto against Pradip Gope @ Dugai Gope S/O- Lt. Kitu Gope of Vill-Dumurhir, PO-Achkoda, PS-Neturia, Dist-Purulia to the effect that on receipt of secret source information of stocking of coal at Ranipur Majhi Para, near Kabristhan under Raibandh GP, PS-Neturia, Dist-Purulia, myself along with C/159 Dinesh Sardar, C/1550 Bharat Ghosh and NVF/660 Ranjit Kumbhakar left for Ranipur Majhi Para, near Kabristhan under Raibandh GP, PS-Neturia vide Neturia PS GDE No- 1134 Dated: 25.11.2022 at 22:35 hrs and CC No- 3770/22 Dt. 25.11.2022 to work out the information. After reaching there at about 23:55 hrs, I found that huge quantity of hard steam coal was stocked at coal depo of Pradip Gope @ Dugai Gope S/O- Lt. Kitu Gope of Vill-Dumurhir, PO-Achkoda, PS-Neturia, Dist-Purulia situated at Ranipur Majhi Para, near Kabristhan under Raibandh GP, PS-Neturia, Dist-Purulia. We searched for anyone nearby surrounding area of coal depo but none turned up as it was midnight. There is strong reason to believe that the owner of the coal depo namely Pradip Gope @ Dugai Gope procured and stocked the said coal either by theft or by any fraudulent means after hatching a criminal conspiracy and he was trying to dispose of the same coal in a clandestine manner as per his regular practice to different areas knowing it to be stolen.


Accordingly, I seized hard steam coal weighing about 200 MT and out of it 05 kg as sample under proper seizure list duly signed by available witnesses and necessary arrangement has been made for shifting the seized hard coal at Neturia PS with the help of JCB, dumper provided by Khan Transport, Inanpur, PS-Neturia, Dist-Purulia.

On returning to Neturia P.S. and after consultation with PS record it could be learnt that he was involved in several such type of cases, So, I start Neturia PS Case No- 120/2022 Dt.- 26/11/2022 U/S- 379/411/413/414/120B IPC & Section 30(2) of CMN Act against Pradip Gope @ Dugai Gope S/O- Lt. Kitu Gope of Vill-Dumurhir, PO-Achkoda, PS-Neturia, Dist-Purulia.
