Sub: Prayer for starting a specific case against Rajjak Ansary S/O- Lt. Sabiruddin @ Dharu Ansary of Vill-Dumurhir (Raibandh Para), PO-Achkoda, PS-Neturia, Dist-Purulia.

Sir,

In producing herewith the seizure list Dt. 26.11.2022 along with seized 90 MT (approx) hard steam coal from the coal depo running by Rajjak Ansary S/O- Lt. Sabiruddin @ Dharu Ansary of Vill-Dumurhir (Raibandh Para), PO-Achkoda, PS-Neturia, Dist-Purulia situated at Ranipur More under Raibandh GP, PS-Neturia, Dist-Purulia. I beg to report that on 25.11.2022 myself along with C/3221 Swapan Giri and C/2762 Snehanshu Karmakar all are of Raibandh camp under Neturia PS, Dist-Purulia performing mobile duty vide Raibandh Camp under Neturia PS GDE No- 395 Dated: 25.11.2022 and CC No- 340/22 Dt. 25.11.2022 and at about 23:25 hrs as per your kind order left for Ranipur More under Raibandh GP, PS-Neturia to work out the information. After reaching there at about 23:45 hrs, I found that huge quantity of coal was stocked inside the coal depo of Rajjak Ansary S/O- Lt. Sabiruddin @ Dharu Ansary of Vill-Dumurhir (Raibandh Para), PO-Achkoda, PS-Neturia, Dist-Purulia. We searched for anyone nearby surrounding area of coal depo but none turned up as it was midnight. There is strong reason to believe that the owner of the coal depo namely Rajjak Ansary S/O- Lt. Sabiruddin Ansari @ Dharu procured and stocked the said coal either by theft or by any fraudulent means after hatching a criminal conspiracy and he was trying to dispose of the same coal in a clandestine manner as per his regular practice to different areas knowing it to be stolen.

Accordingly, I seized hard steam coal weighing about 90 MT and out of it 05 kg as sample under proper seizure list duly signed by available witnesses and necessary arrangement has been made for shifting the seized hard coal at Neturia PS with the help of JCB, dumper provided by Khan Transport, Inanpur, PS-Neturia, Dist-Purulia.

I, therefore, pray before you kindly lodge an FIR against Rajjak Ansary S/O- Lt. Sabiruddin @ Dharu Ansary of Vill-Dumurhir (Raibandh Para), PO-Achkoda, PS-Neturia, Dist-Purulia as per law and arrange for its investigation.
