Respected Sir,

With due respect I, SI Banshilal Mahato of Neturia PS, beg to submit before you that on 04/11/2022 at about 11.15 hrs while myself along with force C/1302 Radhagobinda Dhibar and C/1550 Bharat Ghosh were performing day mobile duty vide Neturia PS GDE No. 146 Date- 04/11/2022.at Sarbari Bazar on Purulia-Barakar Road. I found one Motor cycle was coming from Raghunathpur side towards Barakar side with driving in excessive speed. Police personnel, present there in proper Police uniform raised hand and directed him to stop the vehicle but he violated the Police Signal and endangering human life by rash and negligently driving of the vehicle which may cause accident to the road user any time. After long chase we can able to apprehend him near Sonu Hotel, PS-Neturia. On interrogation he disclosed his identity as Sujal Dom @ Mallick (18 Years) S/O- Raju Dom @ Mallick of Vill-Hanumandanga Ukhra, PO-Ukhra, PS-Andal, Dist-Paschim Bardhaman. interrogation he stated that he is 18 years old, but could not produce any age proof. On being asked he failed to produce any valid documents of the said vehicle. Hence, he violated the provision of Section 279 IPC/184 MV Act. So, I seized the vehicle having Regd. No- WB 38 AW/5633 under proper seizure list duly signed by the witnesses and arrested the above noted offending driver abiding by all the procedure as laid down in Cr.P.C and the latest guide lines of the Apex Court.

So, I pray before you that a specific case may kindly be registered against the accused driver Sujal Dom @ Mallick (18 Years) S/O- Raju Dom @ Mallick of Vill-Hanumandanga Ukhra, PO-Ukhra, PS-Andal, Dist-Paschim Bardhaman, (Rider of Motorcycle vehicle having Regd. No- WB 38 AW/ 5633 (YAMAHA R- 15) committing offence U/S-279 IPC/184 MV Act.
