Sir,

In producing herewith arrested accused persons namely Biswanath Shaw (21 yrs) S/o Jagarnath Shaw, R/O- Thanamore, P.O. & P.S. Kulti, Dist-Paschim Bardhaman along with seized one white colour Bolero Pickup Van bearing Regd. No-WB-37E/0250. I beg to report that today myself along with C/1511 Sudarsan Bauri and 2) NVF/608 Partha Deb Mahato both of Para PS were performing evening mobile duty by Govt. vehicle heading towards Darda Border Raghunathpur to Chandankiyari (SH-8) pitch road under Para PS area vide Para PS Misc C.C No- 3470/22 dtd 08.11.2022 and Para PS GDE No- 339, dtd. 08.11.2022. At about 20.35 hrs, I found one white colour Bolero Pickup Van bearing Regd. No-WB-37E/0250 was coming from Raghunathpur side rashly and negligently. We tried to stop him but the driver of the said vehicle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory answer for his such rush and negligent driving which may cause endanger to the local public and other vehicles.

So, I seized the vehicle after maintaining proper seizure list duly sign by the witnesses. The whole process of seizure was completed in between 20.45 hrs to 20.55 hrs. Then, I arrested him as he violated sec 279 IPC and 181/184 M.V Act. at 21.00 hrs. after observing all formalities regarding arrest. I informed the owner of said seized vehicle arrested driver Biswanath Shaw's over mobile phone.

Hence, I pray that a specific case U/S- 279 IPC and 181/184 M.V Act. may kindly be initiated against Biswanath Shaw (21 yrs) S/o Jagarnath Shaw, R/O- Thanamore, P.O. & P.S. Kulti, Dist-Paschim Bardhaman.
