Sir,

In producing herewith seized articles i.e. 92.640 ton of coal along with proper seizure list and all connected papers.

I beg to report that on 28.11.22 at 16.15 hrs. O/C Para PS received a source information that a huge amount of illegal Coal has damped at Kashiberia village near Rukni morh beside Dubra to Raghunathpur road, opposite side of Kashiberia Baro Bandh and backside of Bravo Sponge Iron Private Limited under Para PS, Dist- Purulia. Accordingly, he direct me to enquiry into the matter and as per direction of O/C Para P.S. myself along with C/1407 Susanta Goswami, C/3010 Kanchan Majhi reached at the spot i.e. Kashiberia village (Lat-23.545446, Long-86.545533) near Rukni morh beside Dubra to Raghunathpur road, opposite side of Kashiberia Baro Bandh and backside of Bravo Sponge Iron Private Limited under Para PS, Dist- Purulia (vide Para PS GDE No-1226 dtd.28.11.22 and C.C. No-3755 dtd.28.11.22) at about 16.45 hrs. and found a huge amount of illegal Coal has been damped there. The place has been covered by boundary wall having an abundant concrete Chimni. I was waiting there for a long time but no one could not turn there or not showed any valid documents in respect of said damped Coal. Then, I hired a Haiba arranged a Dumper bearing Reg. No. WB-55A/3436 for transportation of coal after seized. Thereafter, the said coal loaded this Dumper for three times and arranged to measure it and found total amount of Coal is 92.640 ton. I seized the said 92.640 ton Coal and 03 copies weighing slip after preparing proper seizure list duly signed by the police party as no one was agreed to sign in the seizure list. Approx 05(five) Kg of coal sealed labeled as sample coal from major contraband.

During local enquiry, I came to know that the land owner namely Biswajit @ Mithu Mukherjee S/O-Lt. Dulal Mukherjee of Vill-Gobindapur, PS-Para, Dist-Purulia A/P-Vill-Dubra, PS-Para, Dist-Purulia along with his associate namely Swapan Kr. Murmu S/O-Lt. Balak Murmu of Vill-Mahuda, PS-Para, Dist-Purulia was dealing with Coal which has been procured by means of theft. I brought entrie seized Coal 92.640 ton to PS and damped at PS compound.

Hence I pray that a specific case may kindly be started against land owner namely Biswajit @ Mithu Mukherjee S/O-Lt. Dulal Mukherjee of Vill-Gobindapur, PS-Para, Dist-Purulia A/P-Vill-Dubra, PS-Para, Dist-Purulia along with his associate namely Swapan Kr. Murmu S/O-Lt. Balak Murmu of Vill-Mahuda, PS-Para, Dist-Purulia.
