In producing herewith one arrested accd. person namely Sader Ali Khan (40) S/o Lt. Abdul Latif Khan of Vill- Metyadahar, PS- Garbetha, Dist- Paschim Midnapore along with one Truck bearing Regd. No- WB-33B/8979 loaded with coal approx 20 M.T. with proper seizure list duly singed by the witnesses. I ASI Dipankar Mahanti of Para PS do here by lodged a complaint to the effect that today i.e. on 03.11.2022 at 15.35 hrs O/C Para PS received a secret source information that one Truck loaded with coal will come from Dubra side which has been procured by means of theft or fraudulent means from somewhere. This refers to Para P.S. GDE No. 134, dt. 03.11.2022 and O/C Para PS instructed me to work out the information immediately as I was engaged in Spl. Mobile duty.

Accordingly, myself along with force C/365 Chandi Charan pandey and NVF/608 Parthadeb Mahato both are of Para PS waited in a safe place near Rukni More under Para PS & keeping our PS vehicle in a safe distance. At about 15.55 hrs. we found that the above noted Truck bearing Reg. No. WB-33B/8979 is coming from Dubra side. Accordingly, we are the police personnel in uniform stopped the Truck at Rukni More and interrogate the drive. During interrogation he disclosed his identity as noted above. On demand he failed to produce any valid papers / challan in respect of said loaded Coal, though sufficient time was given. So, there was a strong reason to believe that the owner of the above noted Truck, driver & others procured the same by theft of any other fraudulent means and were transporting the same for some wrongful gain. As such, I seized the said Truck as well as the said loaded Coal approx 20 M.T. with proper seizure list duly sign by the witnesses as no public was ready to put their signature at any paper to avoid police indulgence. I also arrested the above noted accd. person after maintain all formalities regarding arrest.

Therefore, I pray before you that a specific case against the above noted arrested accused driver and owner of Truck bearing Reg. No. WB-33B/8979 bring accompany with others may kindly be started as per proper section of law.
