Sir,

In producing herewith one arrested accd. person namely Bhagbat Bauri (32) S/o-Prabhakar Bauri of Vill- Mohula, PS- Para, Dist- Purulia along with two seized Tractors bearing Reg. Nos- i) WB55A/8250 & ii) WB81/0890 loaded with approx 03 M.T. coal of each Tractor and 05 (five) M.T. Coal which was found in dumping condition, I beg to report that today on 03.11.2022 at 15.45 hrs O/C Para PS received a secret source information that few Tractors is going to be loaded with coal somewhere at Kashiberia area which has been procured by means of theft by illegal means to transport the coal. This refers to Para P.S. GDE No 135, dt. 03.11.2022 and O/C Para PS instructed me to work out the information immediately as I was engaged in evening Mobile duty. Accordingly, myself along with force C/1438 Asish Ghosh, C/1407 Susanta Goswami and NVF/922 Markanda Kumar reached at Kashiberia at 16.15 hrs. and noticed some people with above noted two Tractors is standing there. Seeing Police party they fled away. However, we managed to apprehend one of them as noted above. On interrogation the apprehended person disclosed his identity as the driver of the Tractor bearing Regd. No- WB81/0890 namely Bhagbat Bauri (32) S/o Prabhakar Bauri of Vill- Mohula, PS- Para, Dist-Purulia. I also searched the adjacent area and found approx 05 MT Coal is in dumping condition. On demand, he failed to produce any valid papers in respect of those coals though sufficient time was given. He also discloses about the owner of the land, where the coal was being loaded and dumped is one Swapan Murmu@ Majhi, though yet not verified. The owner of the land had started procuring coals by means of theft to transport these for wrongful gain. It is also came to learnt that the owner of the above noted vehicles and the owner of the land being accompany with others are involved in procuring coal from Jharkhand side to deal with it. So there has sufficient reason to believe that the owners and the drivers of the said vehicles and the owner of the land and others are involved in dealing coal which has been procured by means of theft for transporting the same coal. Hence, I seized the above noted tractors loaded with approx 3 Ton Coals each and 5 M.T. dumped coal with proper seizure list duly sign by the witnesses. I also arrested the above noted person after maintain all formalities regarding arrest.

Therefore, I pray before you that a specific case against the above noted arrested accused person namely (1) Bhagbat Bauri (32) S/o-Prabhakar Bauri of Vill- Mohula, PS- Para, Dist- Purulia, who is the driver of seized tractor having Reg. No. WB81/0890, (2) driver of the another seized tractor having Reg. No. WB55A/8250, (3) owner of the seized Tractor having Reg. No. WB81/0890, (4) owner of the another seized Tractor having Reg. No. WB55A/8250, (5) land owner namely Swapan Murmu@ Majhi where the coal were being loaded and in dumping was found & others may kindly be started as per proper section of law.
