Sub:- Complaint for starting a specific case .
Sir,

In producing herewith one (01) arrested accused namely Nayan Tudu (32 Yrs) S/O- Sanatan Tudu of Vill-Joysingpur, PS-Puncha, Dist-Purulia (Driver of tractor without registration no.) and seized tractor along with trolley without registration number, Chassis No- NHN47100ZND603436 & Engine No- 362201DX loaded with sand approx 100 cft under proper seizure list. I beg to submit that I, SI Sunil Kr Mudi along with C/752 Durjodhan Sing Sardar, JC/1521 Yusuf Ansary all are of Puncha PS were performing evening. mobile duty vide Puncha PS CC No- 2365/22 Dt. 06.11.22 and at about 19:05 hrs received a credible source information that one tractor is going towards Sirisgora side from Bauridiha side under Puncha PS loaded with sand illegally. Accordingly I intimated the matter to you over phone and as per your direction, we reached at Bahtagora more near Sirisgora village to intercept the above noted tractor and at about 19:45 hrs found that above noted tractor was going towards Sirisgora side from Bauridiha side but on seeing the police party the vehicle suddenly stopped 30/50 meter away from us and one person from said vehicle seems to be the driver of the vehicle got down from the vehicle and started running. We chased to apprehend him and in spite of hot chase we managed to apprehend the above noted person. Then we searched the vehicle and found that the vehicle (Tractor) is without registration No., Chassis No- NHN47100ZND603436 & Engine No- 362201DX loaded with sand approx 100 cft. On being asked the detained driver, failed to produce any relevant documents in respect of loaded sand as well as failed to produce vehicle related documents.

So, there is reason to believe that the driver of above noted vehicle as well as the owner of this tractor have collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same sand in a clandestine manner knowing it to be stolen, as per their regular practice.


Accordingly I arrested the above noted accused driver after maintaining all formalities of Hon'ble Apex Court of India and seized the said Tractor bearing Chassis No- NHN47100ZND603436 & Engine No- 362201DX along with trolley without registration number loaded with sand approx 100 Cft. under proper seizure list duly signed by witnesses as well as seized the driving license of the arrested driver under proper seizure list. Hence the driver and registered owner of the said tractor have committed offence.

Under the above fact and circumstances a specific case may kindly be started against driver of said Tractor namely Nayan Tudu (32 Yrs) S/O- Sanatan Tudu of Vill-Joysingpur, PS-Puncha, Dist-Purulia and the owner of the said tractor as per law and arrange for its investigation.


