Sub: Request for lodging FIR against arrested accused person Sk. Alauddin (22 yrs.) S/O Sk. Kadam Ali of Vill- Lalurdih, PO-Natundih, PS Raghunathpur, Dist.-Purulia.

Sir,

In producing herewith arrested accused Sk. Alauddin (22 yrs.) S/O Sk. Kadam Ali of Vill- Lalurdih, PO-Natundih, PS Raghunathpur, Dist-Purulia along with seized one motorcycle (Apache) having registration No. WB82E/2464.

I beg to report that today (31.10.2022) I SI Abhijit Singha along with C/994 Srikanta Kumbhakar, C/624 Pradip Chakraborty and NVF/187 Upinath Tudu all of Purulia (M) PS were performing mobile duty vide Purulia (M) PS C.C No 3860/22 dtd 31.10.2022 and while we reached at near Bandhan Cement Factory on Purulia-Barakar road (sh-05) under Purulia (M) PS area at about 12:05 hrs, we found one Apache Motor Cycle was coming from Raghunathpur side towards Purulia Town with rash and negligently. We tried to stop him but the rider of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such riding. After a hot chase we could be able to stop him at Bandhan Cement Factory under Purulia (M) PS. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. On demand he also failed to produce any driving license.

Accordingly, I seized the motor cycle having registration No- WB82E/2464, Engine No – AE8BMZ216319 & Chassis No-MD634AE86M2B16539 (Apache) with a view to prosecute him US 279 IPC and 181/184/128/194C MV Act. The whole process of seizure was completed in between 12.05 hrs. and 12.25 hrs. I also arrested him at 12:30 hrs. as he violated sec 279 IPC and 181/184/128/194C MV Act in presence of police party. His family member was also informed over cell phone about the ground of arrest.

Hence, I pray that a specific case U/S 279 IPC and 181/184/128/194C MV Act may kindly be initiated against accused Sk. Alauddin (22 yrs.) S/O Sk. Kadam Ali of Vill- Lalurdih, PO-Natundih, PS Raghunathpur, Dist.-Purulia and arrange its investigation.
