Sub:-Prayer for starting a specific case against namely (i) Purna Chandra Mahato (54 yrs) s/o Mahabar Mahato & (ii) Fulu Mahato (46 yrs) w/o Purna Chandra Mahato both are Vill-Dumdumi Namu Para, PS-Purulia(M) , Dist-Purulia.

Respected Sir,

In producing herewith two (02) accused persons namely (i) Purna Chandra Mahato (54 yrs) s/o Mahabar Mahato & (ii) Fulu Mahato (46 yrs) w/o Purna Chandra Mahato both are Vill-Dumdumi Namu Para, PS-Purulia(M) Dist-Purulia under arrest and the following seized articles under seizure list enclosed herewith:

- 1) Forty Eight (48) sealed plastic bottles (CS) containing 600 ml each and labelled with DILKHUSH.
- 2) One nylon basket

I SI Abhijit Singha of this PS do hereby lodge this complaint regarding that today (11.11.2022) at about 07:55 hrs during my spl raid duty at Dumdumi village received a source information over telephone that the above noted accused persons have been selling CS liquor illegally and clandestinely at their house of village Dumdumi under Purulia (M) PS. On receiving the reliable source information I communicated with I/C Purulia(M) PS over telephone and as per his instruction I along with force (i) C/178 Tulsi Mahato, (ii) C/699 Biswajit Banerjee & (iii) LC/1112 Archana Roy all of Purulia(M) PS rushed to the spot to work out the information. On arriving to the spot at 08:25 hrs I apprehended the above noted persons after a strong attempt and one customer seeing the Police party managed to escape. On close interrogation that apprehended persons had disclosed their name & address as noted above. I asked them to produce any valid paper in support of selling that liquor but they failed to produce any legal paper or document in support for selling such liquor. Accordingly I seized all those noted above after preparing proper seizure and labelled the seized articles duly signed by the accompanying party and accused persons in the seizure list and the label in between 08:35 and 08:45 hrs. One bottle 600 ml liquor has been kept as sample taken from that seizure as sample which was also duly labelled and also took signature of the accompanying witness & accused persons on seizure list and label. After this I arrested those accused persons namely (i) Purna Chandra Mahato (54 yrs) s/o Mahabar Mahato & (ii) Fulu Mahato (46 yrs) w/o Purna Chandra Mahato both are Vill-Dumdumi Namu Para, PS-Purulia(M) Dist-Purulia after preparing proper memos of arrest at 08:50 hrs & 08:55 hrs.

Under the above facts & circumstances I pray before your honour that a specific case may kindly be started against the accused persons under proper section of law and arrange for investigation.
