Respected Sir,

In producing here with 02(two) accused persons namely (1) Chandan Kumar(35),s/o-Chunilal Yadav of Meherdibagan, Burdwan Sadar PS, Purba Bardhaman PIN-713101 (2) Bapi Maji(28),s/o-Ajit Maji of Siyarsuli village,PS-Kundahit, Dist-Jamtara, Jharkhand, A/P-Saktigarh Puratan Basti, PS-Saktigarh, Dist-Purba Bardhaman WB 713149 along with 02 (two) seized vehicles (Truck full body) having registration Nos (1) NL01L/2111 loaded with approx twenty four(24) TN (2) WB37D/0409 loaded with approx 30 TN coal seems to be steam coal and also taken sample of 05 kg coal from each truck to the effect that I SI Basudeb Acharya along with C/683-Monsaram Rajak, NVF/187-Upinath Tudu all are of Purulia (M)PS were engaged in mobile duty vide Purulia(M) Spl. CC No-178/22 Dtd-23.11.2022and PS GDE No-1135 Dtd-23.11.2022 at about 17.05 Hrs in course of mobile duty at Ghonga road received a credible source information that two(02) vehicles (Truck full body) loaded with illegal coal were coming from Chandankeyari side(Jharkhand). After receiving information contacted with my I/C and informed the matter and as per kind order myself accompanied with force immediately proceeded towards the Vehicles and managed to stop the vehicles near Ghonga Petrol pump on Purulia-Chandankeyari road on 23.11.2022 at about 17.15 hrs, on seeing the Police party 01/02 persons were tried to flee away but somehow we managed to apprehend the above noted persons. On asked they failed to produce any valid documents in respect of loaded coal. On preliminary enquiry it could be learnt that they were procured the said illegal coal from different places and transporting the same in a clandestine manner to another district/state. So, it is reasonable to believe that they were transporting the coal illegally after procuring. Accordingly I seized the above noted vehicles loaded with coal under proper seizure list duly signed by the accompanied Police persons in between 17:35 hrs. and 17:55 hrs. as there was no availability of any local person, as such I could not collect the signature of the local people in all seizure list and during seizure I had taken 05 Kg coal from each truck as sample. After that I arrested them after observing all formalities regarding arrest 18:05 hrs. and 18:15 hrs. After that we made proper arrangement and brought the vehicles loaded with coal at PS to keep at PS compound.

Therefore, I pray that a specific case may kindly be registered against above noted arrested persons, driver and owner of the 02 (two) seized vehicles, owners of the two vehicles and other associates under proper section of law.
