No unknown dashed behind him with high speed and negligent manner for such impact he fell down by the side of road and sustained severe bleeding ,head injury. With the help of local people he were shifted to the kustaur BPHC, but his critical condition doctor referred him to Purulia Deven Mahato Sadar Hospital, Then referred to bokaro general hospital, But his condition day to date deteriorted with cause he referred to IQ CITY medical collage and hospital Durgapur for better treatment, where he died on 09.09.2022 under his treatment at said hospital...which P.M. was held over the dead body of the deceased at S.D.
