- 2.---That on 05-09-2022 corresponding to 19th day of Bhadra 1429 B.S. at about 4.00 P.M. when the complainant was working in his cow-shed, then anyhow the cow-culf escaped from the cowshed and entered into the house of the accused persons, the accused persons started abusing the complt, then the complainant came there and any how remove the cow-culf from the custody of accused persons. And after complete his work, when the complainant was taking rest to his house, then the accused persons armed with ~~xx~~ Lathi entered into the house of the complainant, they started abusing to the complainant, then the complainant protested of their illegal act but they did not pay any heed at the request of the complainant. Suddenly accused persons assaulted the complainant by fist and blow and lathi as a result the complainant feld down on the ground and the complainant makes a noice by saying Bancho-Bancho. Hearing the news the witnesses came there and saved the complainant from the hands of the accused persons, the witnesses came there and saw the incident. Then the accd. persons left the place with dire consequence.

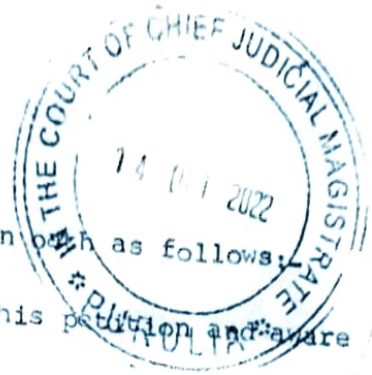
