***Complainant above named beg to state as follows:***

**Fact of the Case:**

- 1) That, the Accused Person No.1 Ashari Mahato executed an agreement in respect of R.S. Plot No. 393, 394, 1541 & 237 of Mouza Ketika on 25.10.2021 and took sum of Rs.1,50,000/= ( Rupees one lakh fifty thousand only) from the Complainant and one Debabrata Banerjee, and promised that he sell the said property to the Complainant and Debabrata Banerjee within three months and total amount of fixed sum of Rs. 16,00,000/= (Rupees sixteen lacks only) and his sons are the witnesses in the said agreement, but within three months they promised that they sell the same within 2 years and deferred the matter on some pretext or otherwise when the Complainant requested to the Accused Person No.1 Ashari Mahato to execute a Regd. Deed of Sale by receiving rest consideration of money but on 18.10.2022 and 19.10.2022 at about 10:00 A.M All the Accused persons and one Saiyad Raju (who is Accused No. 5) are threatened to the Complainant that they will murder to the Complainant and throwing vulgar language to Complainant at Ketika Purulia and also threatened us that if any complaint will lodge from outside then they shoot us by gun. .
- 2) That, thereafter the Complainant informed the matter before the S.P. Purulia on 20.10.2022 but till now no take was taken by the Concern Authority. So the Complainant file this petition for his life protection.

It is prayed, that your Honour would be pleased to admit the petition and send this petition to O.C. Purulia Town P.S. and directing him to treat this petition as F.I.R. against the accused persons and also pass necessary order which will deemed fit and proper.
