Sub: Prayer for lodging F.I.R. against arrested accused person Biswanath Khan (56 yrs) S/O- Late Balaram Khan of Nadiha, Near Misti Mahal, Ward No-06, PS- Purulia (T), Dist- Purulia

Sir.

In producing herewith one arrested accused person namely Biswanath Khan (56 yrs) S/O- Late Balaram Khan of Nadiha, Near Misti Mahal, Ward No-06, PS- Purulia (T), Dist- Purulia under arrest along with following seized articles under proper seizure list and being labeled properly:-

- (1) 18 (Eighteen) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 600 ml of country spirit having strength 80⁰ UP and MRP is Rs 55/- being sealed properly) blended and bottled by Purulia Bottling Pvt. Ltd., Vill+ PO Lagda, Dist. Purulia, Pin 723149.
- (2) Out of 18 (Eighteen) bottles 01(one) bottle is kept as sample.

I, PSI Ashoke Mahata, beg to report that while I was performing Evening mobile duty vide Purulia (T) PS GDE No- 1050 dated 19.11.22, at about 20:35 hrs received a secret telephonic information from source that one person namely, Biswanath Khan (56 yrs) S/O- Late Balaram Khan of Nadiha, Near Misti Mahal, Ward No-06, PS- Purulia (T), Dist- Purulia is selling country spirit illegally at a higher price causing unlawful gain to him by unlawful loss to the purchasers from his dwelling house.

Accordingly I informed the matter to I/C, Purulia (T) PS and after getting his permission myself alongwith my team consisting of C/586 Bholanath Dey and C/295 Badrul Hazari all of Purulia (T) PS proceeded to work out the information.

At 20:55 hrs. we reached at Nadiha, Near Misti Mahal keeping our Govt. vehicle at a reasonable distance we proceeded towards his dwelling house near Misti Mahal at Nadiha as informed by the source and found that the said person was selling Country Spirit as noted above to some persons and some persons were found drinking there. Seeing the police, all of them tried to flee away leaving some plastic glasses at the spot. On hot chase one of them could be nabbed. On interrogation he confessed his guilt as he was selling Country Spirit as noted above to the locals without having any authority at a higher price since long. He also failed to produce any license in favour of selling, keeping or possessing Country Spirit and the said person disclosed his identity as noted above. On search of the house we found 18 (Eighteen) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 600 ml of country spirit having strength 80° UP) blended and bottled by Purulia Bottling Pvt. Ltd., Vill+ PO Lagda, Dist. Purulia, Pin 723149. As such at about 21:05 hrs to 21:25 hrs I seized the above noted Country Spirit under proper seizure list in presence of witnesses after labeling and seal properly. I also took samples and arrested him at 21:45 hrs observing all the formalities as the said person committed an offence which attracts sec. 46 (A) (C) of B.E. Act 1909.

Hence, I pray before you to start a specific case against the above noted person under proper section of law and kindly arrange for its investigation.
