Respected Sir,

I Rishab Khedia s/o Sri Pradip Kumar Khedia resident of Munseffdanga, Ward No-3, Purulia is the owner of M/s Jayshree Electronics situated at N.L Ghosh Street, Taxi Stand Purulia. We deal in Mobile Handset and Mobile Accessories Retail of various Brands.

This is to inform you that on 19.11.2022 i.e yesterday I closed my shop around 9.15 PM and on 20.11.2022 today morning at 10:30 A.M when I opened the shop I found that the shutter gate of my shop was damaged/bent and I found that stocks from my shop were stolen.

76 pcs of Mobile Handsets were stolen but the empty boxes of the said handsets were torned and left behind in the shop premises and 75 pcs. Of sealed Mobile Handsets of different brands along with the boxes are found to be stolen, IMEI of which are not tracable. Total No of Handsets stolen are 151 pcs. Value amounting to Rs. 2179629/-
Accessories amounting to Rs. 114500/- were also stolen
Cash Amounting Rs 50180/- was also taken from the Cash Box

The modelwise details for the same has been attached in annexure 1 and IMEI details has been attached in Annexure 2.

I request you to kindly investigate the matter and do the needful at the earliest as this has affected me with a huge monetary loss.
