Sir.

In producing herewith the arrested accused person namely Sujoy Bouri (32) S/o Paban Bouri of Boragoria, PS- Raghunathpur, Dist.- Purulia and seized one Bolero Pick up van bearing Registration No. WB 81/2335 loaded with 03 (three) MT (Approx) Steam Coal and (2) One Electric Weight Machine. Fact of the case in brief is that on 31.10.2022 myself along with C/1519 Seikh Haidar Ali and C/737 Haradhan Nayak both of Raghunathpur PS were performing special raid duty in Raghunathpur PS area vide Raghunathpur PS CC No. 2139/22. At about 04:55 hrs. received a credible source information that some persons were assembled for loading coal in a pick up van with a view to illegal transporting near at Koradanga village (Sankra) under Raghunathpur PS. After receiving such information I informed the matter to IC Raghunathpur PS and as per his kind direction we reached near at Koradanga village (Sankra) and parked the vehicle from a distance. Then we have cordoned the place by our police personnel and found that some persons were loading coal in a pick up van, which was standing there. Seeing Police personnel unknown persons were fled away from there. At that time we were able to apprehend the driver of the said pick up van. On asking the driver of the said vehicle failed to produce any papers in respect of said loaded Coal as well as papers in respect of the above noted vehicle. He also made incoherent statements in respect of possession of the said coal. So, it is reasonable to believe that the driver of the vehicle bearing Reg. No. WB 81 2335, owner of the vehicle and others have been collected the said coal either by theft or by any fraudulent means from anywhere and transporting the same to run clandestine business for wrongful gains with the help of others. On interrogation he confessed his guilt and stated that his associates namely -(1) Ashis Bouri S/o Paban Bouri of Boragoria, PS - Raghunathpur, Dist.- Purulia (Owner), (2) Akhil Bouri @ Ukil S/o Not Noted of Lalpur (Joypur), PS - Raghunathpur, (3) Sima Gorai S/o Shyamapada Gorai of Bamarrah, PS - Raghunathpur, Dist.- Purulia and 03/04 others are directly involved in this case. As such it is every reason to believe that they are transporting the said coal illegally. So, I seized the above noted pick up van loaded with Coal approx 03 MT (Approx) under proper seizure list duly signed by the accused persons and witnesses. I also arrested the above noted driver after observing all formalities and narrating his ground of arrest. No public witnesses were turned up there. Approx 01 (One) K.G. Coal collected from the seized vehicle as sample.

I therefore pray before you, kindly lodge an FIR against the arrested accused persons namely (1) Sujoy Bouri (32) S/o Paban Bouri of Boragoria, PS- Raghunathpur, Dist.- Purulia, (2) Ashis Bouri S/o Paban Bouri of Boragoria, PS – Raghunathpur, Dist.- Purulia (Owner), (3) Akhil Bouri @ Ukil S/o Not Noted of Lalpur (Joypur), PS – Raghunathpur, (4) Sima Gorai S/o Shyamapada Gorai of Bamarrah, PS – Raghunathpur, Dist.- Purulia and 03/04 others as per law and arrange for its investigation.
