Sub:- Initiation of penal action against GRS & VLE of Bero GP

In the matter of Sarifuddin Sk and 7 others Vs union of Indian and others i.c.w. WPA(P)116 of 2022 (Annexure 1), Hon'ble Justice sri Prakash Shrivastava and hon'ble Justice Shri Rajarshi Bhardwaj, High Court at Calcutta disposed the above-mentioned writ petition by directing the respondent no. 4, the District Magistrate, Purulia to get the enquiry conducted under his supervision (Annexure II),

And where as in compliance of the order of the hon'ble High Court, Calcutta the District Magistrate, Purulia directed PO & BDO, Raghunathpur I to complete the process of enquiry, to find out the persons responsible for misappropriation of funds, to recover the misappropriated funds and to start penal action against the persons found guilty vide memo no. 5501(4)/MGNREGA/PRL dated 27/07/2022 (Annexure III),

And where as Sekh Sarifuddin, Vill-Fulberia and seven others were called for hearing on 03/08/2022 at 12 noon at the Meeting Hall of Raghunathpur-I Panchayat Samity vide memo no. 1408/BDO/RNP-I dated 28/07/2022. Sekh Sarifuddin and seven others attended the hearing on 03/08/2022 and filed hazira. Block level enquiry team visited Gram Panchayat Office and made field visit in presence of Sekh Sarifuddin & others from 29/08/2022 to 06/09/2022 vide memo no. 1686/MGNREGA/RNP-I dated 24/08/2022.

In reference to complaint no. 2 where it has been alleged that MGNREGA works have not been done on beneficiaries' personal land the followings are to be noted-

In case of UM Exc farm pond of Gour Mandal (work code 3214015003/IF/PP/1032195)
Paschim Bero, mouza plot no. 1920 Jl. no. 194. Beneficiary Ramnath informed that IBS scheme was not implemented in his land. However, a report has been sought from BL&LRO Raghunathpur-I requesting land records where scheme is reported to be implemented together with name of the land owner and land details vide memo no. 1691/MGNREGA/RNP-I dated 08/09/2022 (Annexure- IV). It is reiterated that IBS beneficiary denies the execution of schemes on his/her land.

In case of UM Exc farm pond of Shyamapada Bauri (work code 3214015003/IF/PP/1032184) Paschim Bero, mouza plot no. 9674 Jl. no. 194. Beneficiary Shyamapada Bauri informed that IBS scheme was not implemented in his land. However, a

Beneficiary Sk Kurban informed that IBS scheme was not implemented in his land. However, a report has been sought from BL&LRO Raghunathpur-I requesting land records where scheme is reported to be implemented together with name of the land owner and land detail vide memo no. 1691/MGNREGA/RNP-I dated 08/09/2022 (Annexure- IV). It is reiterated that IBS beneficiary denies the execution of schemes on his/her land.

In case of UM Exc farm pond of Dayamay Paramanik (work code 3214015003/IF/GIS/745446) Purba Bero, mouza plot no. 7535 Jl. no. 195. Beneficiary Dayamay Paramanik informed that IBS scheme was not implemented in his land. It is relterated that IBS beneficiary denies the execution of schemes on his/her land.

In case of UM Exc farm pond of Madhuri Mandal (work code 3214015003/IF/GIS/978495) Paschim Bero, mouza plot no. 4158 Jl. no. 194. Beneficiary Mithu Mandal W/O Niranjan Mandal informed that IBS scheme was not implemented in his land. However, a report has been sought from BL&LRO Raghunathpur-I requesting land records where scheme is reported to be implemented together with name of the land owner and land detail vide memo no. 1691/MGNREGA/RNP-I dated 08/09/2022 (Annexure- IV). It is reiterated that IBS beneficiary denies the execution of schemes on his/her land.

· In case of UM Exc farm pond of Bhim Swarnakar (work code 3214015003/IF/PP/1032190) Purba Bero, mouza plot no. 1063 Jl. no. 195. Beneficiary Nitai Swarnakar informed that IBS scheme was not implemented in his land. However, a report has been sought from BL&LRO Raghunathpur-I requesting land records where scheme is reported to be implemented together with name of the land owner and land detail vide memo no. 1691/MGNREGA/RNP-I dated 08/09/2022 (Annexure-IV). It is reiterated that IBS beneficiary denies the execution of schemes on his/her land.

In case of UM Exc farm pond of Chandana Pal (work code 3214015003/IF/GIS/738448) Purba Bero, mouza plot no. 8373 Jl. no. 195. Beneficiary Chanchal Pal H/O Chandana Paul informed that IBS scheme was implemented in his land. However, a report has been sought from BL&LRO Raghunathpur-I requesting land records where schemes is reported to be implemented together with name of the land owner and land detail vide memo no. 1691/MGNREGA/RNP-I dated 08/09/2022 (Annexure- IV). It is reiterated that IBS beneficiary denies the execution of schemes on his/her land.

In all the above cases the geo tagging of schemes was done by Arup Mandal, then GRS Bero Gram Panchayat on land other than the land of the beneficiary with a malafide intention in clear violation of MGNREGA guidelines.

And where as engaged supervisors submitted written depositions that the IBS schemes were implemented as and where guided and directed by Arup Mandal, then GRS Bero Gram Panchayat (Annexure- V).

BL&LRO Raghunathpur-I submitted the following reports, vide memo no. 1122/BL&LRO/RNP-I/22 dated 19/09/2022 (Annexure- VI) and memo no. 1135/BL&LRO/RNP-I/22 dated 26/09/2022 (Annexure- VII). Where it is stated that, the above mentioned MGNREGS Individual Beneficiary Schemes were implemented in land other than the land of individual beneficiary.

Moreover it is to be noted that, some of the above mentioned schemes were also implemented on vested plots in remote and isolated locations so as to avoid public scrutiny.

Based on the replies received against show cause notices issued, deposition received during hearing and written submission of concerned supervisors, it appears that Sri Arup Mandal, S/O Krishnapada Mandal residing at Paschim Bero, Panchpahari Godibero, Purulia, West Bengal-723133, Ex Gram Rojgar Sevak, Bero Gram Panchayat has not exercised due care and diligence in geo tagging of locations of Individual Beneficiary's land, with an intent to defraud and mis appropriate Govt. fund.

And where as in reference to complaint no 1 regarding disbursement of MGNREGA wages to dead persons showing them alive in the musterroll, both GRS and VLE, Bero Gram Panchayat were directed vide memo no. 1018/MGNREGA/RNP-I dated 20/05/2022 and memo no 1019/MGNREGA/RNP-I dated 20/05/2022 that the mis appropriate amount of Rs. 150751/- (Rupees one lakh fifty thousand seven hundred fifty one) be recovered and

deposited with the undersigned. However the mis appropriate said amount has not been deposited with the undersigned.

Based on the replies received against show cause notices issued, deposition received during hearing it appears that Sri Bappaditya Sutradhar, S/O late Swapan Sutradhar , residing at Village+ Post-Arrah, Purulia, West Bengal-723121 Ex Village level Entrepreneur, Bero Gram Panchayat has not exercised due care and diligence during entry of job card details and bank account details based on proper documents with an intent to defraud and mis appropriate of Govt. fund. Subsequent to which MGNREGA wages were credited to dead persons' accounts, showing them alive in the muster roll.

And where as the undersigned is directed by Addl District Magistrate(Gen) & Addl District Programme Co-ordinator, Purulia to 1) initiate penal action against GRS & VLE of Bero Gram Panchayat, 2) recover the defalcated amount vide memo no 717/MGNREGA/PRL dated 20/10/2022(Annexure- VIII), I Sri Ravi Shankar Gupta, S/O Lakhi Prasad Gupta, BDO Raghunathpur I, having office at Raghunathpur, Purulla-723133 do hereby file FIR against the below mentioned persons for mis appropriations of Govt. funds leading to fraud and corruption.

- 1) Sri Arup Mandal, S/O Krishnapada Mandal residing at Paschim Bero, Panchpahari Godibero, Purulia, West Bengal-723133, Ex Gram Rojgar Sevak, Bero Gram Panchayat
