

That on the day of incident at relevant point of time all the accused persons in order to fulfill their ulterior motive entered into the house of the complt. and gave out threat aiming to the complt with ~~addressing~~ abusive languages in which parent of the complt raised protest against such illegal and overt act of the complt. Whereupon Accd. persons grew furious and Accd. persons No. 1 to 3 used unutterable obscene language towards the mother of the complt. with a view to insult the modesty of mother of the complt. Needless to say soon complt came inside the room all the Accd. persons attacked the complt. mercilessly with fist kicks and blows upon the person of the complt. as a result complt sustained a severe injury and fell on the ground Acc. persons also tore the wearing apparels of complt. Parents and other inmates anyhow saved the complt from the savage clutches of the Accd. person.

4. That accd. persons before leaving the place of occurrence gave out threat with dire consequences to finish the life of complt. of on opportune moment.

5. That complt got himself treated to Medical Officer at Raghunathpur BPHC on 8/10/22.

6. That complainant also reported the matter in writing to I/C, Raghunathpur for taking appropriate action against the Accd. persons but till date no action has yet been taken. Thereafter complt sent his grievances to the S.P. Purulia vide Regd. Post on 18/10/22 but the same has not come to fruitful thus finding no other alternative complt compels to file the instant case against Accd. person before the court.

It is therefore prayed that an order report I/C Raghunathpur to cause investigation into the matter treating the instant as

F.I.R.U/S.156(3) Cr.P.C. may kindly be passed.
