

Complainant most respectfully sheweth: -

1. That the complainant is a local resident of Raghunathour Tanti para, Ward NO: -03, having his dwelling house there is.

2. That accd. persons are the neighbourers , resident and very much vimilative and all time bying to do mischief with the person & property of the complainant.

3. That in absence of complainant and his family members accd. persons has raised concrete wall blocking a narrow passage of the complainant approaching towards back side of the dwelling house of the complainant.

4. That on the day of incident at relevant point of time complainant was trying to remove the block in order to dispel the disturbance, at that time accd. persons being furious in red teeth & claws having armed with viz accd. no:01 iron rod acced. no:02 brick and accd. no:03 with Axe entered into the house of the complainant with a view to cause injury to the person of the complainant and gave out threat "Second FID BORO SAHAS TUI AMAR KAJER UPAR HAATH LAGAS" TOKE JIBONE SESH KOREDEBO, KEO BACH: TE PARBENA", Accd. ho:-02 also threathe brick towards complt's but anyhow complaint saved himself from such attack. However wife and son and some others came to the Po seeing such illegal & overt act of the complainant in which for the time being accd. were prevented but they gave out threat to finish the life of complainant and his family members on opportunte moment.
