Sir,

In producing herewith the arrested accused persons namely (1) Rathin Garain (32) S/o Nepal Garain of Vill.- Barraha, PS – Raghunathpur, Dist.- Purulia, (2) Satrugan Garain (32) S/o Lt. Tarapada Garain of Vill.- Anantapur, PS- Santaldih, Dist.- Purulia, (3) Pradip Kr Singh (22) S/o Lt. Ram Naresh Singh of Vill.- Laxmi Colliery, Parbadh, PS – Jorapakhur, Dist.- Dhanbad (Jharkhand), (4) Suraj Kumar (25) S/o Bramdeb Saw of Do, (5) Shivan Bharti @ Shivam Raj (20) S/o Sri Ganesh Rabidas of Do, (6) Amit Kumar Nishad @ Pintu Kumar Nishad (25) S/o Sankarlal Nishad of Do and (7) Md. Noushad (40) S/o Md. Abul of Vill.- Chas Ansari Mahalla Karbala Road, PS – Chas, Dist.- Bokaro (Jharkhand) and seized 07 (Seven) Nos. of Two wheelers loaded with approx 31 Qntls. Steam Coal. Fact of the case in brief is that on 19.11.2022 myself along with SI Mukul Karmakar, SI Biswajit Sarkar, C/386 Sibendu Sinha, C/312 Radheshyam Mandal all of Raghunathpur PS were performing special mobile duty in Raghunathpur PS area vide Raghunathpur PS CC No. 2236/22. At about 05:05 hrs. received a credible source information that the above noted two wheeler loaded with coal were assembled and coming from Kargali side towards Chelyama. After receiving such information I informed the matter to IC Raghunathpur PS and as per his kind direction we reached near at Block Office – II, Raghunathpur on Kargali – Chelyama Road and parked the vehicle from a distance. Then we have cordoned the place by our police personnel and found that some persons having loaded coal with two wheeler were coming, at that time we were able to apprehend 07 (Seven) Nos. of Two wheeler with loaded coal and there riders. On asking the riders of the said two wheelers failed to produce any papers in respect of said loaded Coal as well as papers in respect of those two wheelers. They also made incoherent statements in respect of possession of the said coal. So, it is reasonable to believe that the rider of those two wheelers collected the said coal either by theft or by any fraudulent means from anywhere and transporting the same to run clandestine business for wrongful gains with the help of others. On interrogation they confessed their guilt. As such it is every reason to believe that those persons along with two wheelers are transporting the said coal illegally. As such I arrested of those persons after observing all formalities and narrating their ground of arrest. I also seized those two wheelers loaded with Coal under proper seizure list duly signed by the accused persons

and witnesses. No public witnesses were turned up there. Approx 01 (One) K.G. of Coal in each two wheelers collected as sample coal.

I therefore pray before you, kindly lodge an FIR against the arrested accused persons namely (1) Rathin Garain (32) S/o Nepal Garain of Vill.- Barraha, PS – Raghunathpur, Dist.- Purulia, (2) Satrugan Garain (32) S/o Lt. Tarapada Garain of Vill.- Anantapur, PS- Santaldih, Dist.- Purulia, (3) Pradip Kr Singh (22) S/o Lt. Ram Naresh Singh of Vill.- Laxmi Gollery, Parbadh, PS – Jorapakhur, Dist.- Dhanbad (Jharkhand), (4) Suraj Kumar (25) S/o Bramdeb Saw of Do, (5) Shivan Bharti @ Shivam Raj (20) S/o Sri Ganesh Rabidas of Do, (6) Amit Kumar Nishad @ Pintu Kumar Nishad (25) S/o Sankarlal Nishad of Do and (7) Md. Noushad (40) S/o Md. Abul of Vill.- Chas Ansari Mahalla Karbala Road, PS – Chas, Dist.- Bokaro (Jharkhand) as per law and arrange for its investigation.
