Sir,

In producing herewith the seizure list dated- 25.11.2022 in which seized 60 MTs (Approx) Steam Coal, 05 Belcha and 06 Jhuri (Bucket) from inside the boundary running by (1) Goutam Gorai S/o Abinash Gorai of Vill.- Kargali, PS – Raghunathpur, Dist.- Purulia and (2) Biswanath Gorai S/o Abinash Gorai of Do. I beg to report that on 25.11.2022 myself along with SI Muktipada Ghosh, SI Biswajit Sarkar, SI Mukul Karmakar, C/312 Radheshyam Mandal, C/600 Amit Shit, NVF/1089 Swapan Paramanik, C/2389 Pinku Saha, C/386 Sibendu Sinha all of Raghunathpur PS were performing special mobile duty in Raghunathpur PS area vide Raghunathpur PS CC No. 2284/22. At about 00:15 hrs. received a credible source information that huge quantity of coal were stocked at inside the said boundary situated at Kargali with a view to illegal transporting the same in lieu of money. After receiving such information I informed the matter to IC Raghunathpur PS and as per his kind direction we reached near at Kargali Ghat and parked the vehicle from a distance. Then we have cordoned the place by our Police personnel and found that the huge quantity coal was stocked there. The said illegal coal have collected either by theft or by any fraudulent means from anywhere and transporting the same to run clandestine business for wrongful gains. As such it is every reason to believe that the above noted persons and other involved associates are jointly stocking the said coal illegally. I also seized Coal in between 05:35 hrs to 07:55 hrs under proper seizure list duly signed by the witnesses. Approx 01 (One) K.G. of Coal collected as sample coal.

I therefore pray before you, kindly lodge an FIR against the arrested accused persons namely (1) Goutam Gorai S/o Abinash Gorai of Vill.- Kargali, PS – Raghunathpur, Dist.- Purulia and (2) Biswanath Gorai S/o Abinash Gorai of Do and other involved associates as per law and arrange for its investigation.
