

1. That the complainant is a permanent residential of village:— Mangalda under P.S. Raghunathpur, Dist: Purulia and he is in the possession over and within a Tank & its ail namely "Chapa Pukur which is situated within mouza Mangalda by way of inheritance alongwith other co-owners.

2. That present complainant since last ten years with the consent of other co-sharers has been rearing and catching various fishes within said fank to the full knowledge of local people of said Mangalda Village. Be it noted complainant this year also reared various prawns and fishlings in the said "Chapa pukur" in the month of April 2022 this apart said pond was also abundance with weld grant fished duly reultivated by the complainant.

3. That accd. persons in furtherance of their common intention on the day of incident combindly started catching sufficient amount of fish from the said pond of the complainant by applying heavy Mylon net in the braud day light without any propr permission from the complainant.

4. That hearing such desperate at of the accd. persons complainant had been to the spot where he found about 30 kg of fish of reasonable size have been taken out from the pond, kept in threecontaine still accused used drawing the net in the pond. Seeing such illegal act of accd persons complainant raised protest but the accd. did not care the same rather gave out "JA JA TORE JA KHUSI KOR BESHI KARLE JIBAN IA SESH KORE DEBO".

5. That as soon local public started to assemble there accd. perso -n took away the fish in the containers by their cycles. Due to

such act of action persons complainant has sustained a heavy financial loss and damage .Besides that complainant got shocked owing to such illegal act on the part of the accd. persons.

6. That the complainant reported the matter to the local P.S. at Raghunathpur but no fruitfull result came thereafter complainant sent his grievances to the S.P.Purulia for his remedy through Regd. post but no bas action has yet been taken. Hence finding no other alternative complainant seeks his remedy before the Ld. court.

Therefore prayed that an order upon I/C Raghunathpur P.S.may kindly be passed to cause investigate into the matter treating the ungent petition as a.F.I.R. U/S 156(3) Cr.P.C.


