Sub: Prayer for starting a specific case against Ganesh Rajwar (26 yrs) S/O- Arjun Rajwar of Locoshed Para, Ward No-11, PS- Purulia(T), Dist- Purulia, P/A- Vill- Bhojudih (Nagarmajhidih), PS- Chandankiyari, Dist-Bokaro, (Jharkhand), (Driver of Black Pulsar Motor Cycle having Reg. No.-WB-56S-9167, Engine No-DHXRMH77806 & Chassis No- MD2B68BX5MRH41968).

In producing herewith the arrested accused person Ganesh Rajwar (26 yrs) S/o- Arjun Rajwar of Locoshed Para, Ward No-11, PS- Purulia(T), Dist- Purulia, P/A- Vill- Bhojudih (Nagarmajhidih), PS-Chandankiyari, Dist-Bokaro, (Jharkhand) and seized motorcycle bearing registration no. WB-56S-9167. I beg to submit regarding the fact of the case in brief is that today i.e on 01.11.2022 myself along with C/1337 Subhas Kundu and C/29 Kousik Ghatak, all are of Santaldih I/C BCW were performing surprise naka checking duty at Gowai river bridge vide Santaldih I/C BCW GDE No. 13 Date-01.11.2022 and C.C No- 1323 dated 01.11.2022. During naka checking at 16.05 hrs, I found one Motor Cycle was coming from Nabagram side driving his motorcycle dangerously with excessive speed and without wearing Helmet. We raised hand and directed him to stop the Motor Cycle but the said Motor Cycle rider, violating the Police Signal and endangering human life by rash and negligent driving the Motor cycle which may cause accident to the passerby any time. Somehow we were able to apprehend him. On interrogation he disclosed his identity as Ganesh Rajwar (26 yrs) S/o- Arjun Rajwar of Locoshed Para, Ward No-11, PS- Purulia(T), Dist- Purulia, P/A- Vill- Bhojudih (Nagarmajhidih), PS- Chandankiyari, Dist- Bokaro, (Jharkhand), (Driver of Black Pulsar Motor Cycle having Reg.No.-WB-56S-9167).

On being asked Ganesh Rajwar, driver of the said motorcycle produced Registration certificate, insurance paper and pollution documents in respect of the said motorcycle. He also produced his Driving License. Thus he committed offence U/S 279 IPC read with section 184/194D of MV Act 1988 read with MV (Amendment) Act, 2019. Accordingly I seized the said Black Pulsar Motor Cycle having Reg.No.-WB-56S-9167 and Registration certificate, insurance paper, pollution and driving license from the possession of above noted driver of the said motor cycle namely Ganesh Rajwar under proper seizure list and arrested the offending driver namely Ganesh Rajwar (26 yrs) S/o- Arjun Rajwar of Locoshed Para, Ward No-11, PS-Purulia(T), Dist- Purulia, P/A- Vill- Bhojudih (Nagarmajhidih), PS- Chandankiyari, Dist- Bokaro, (Jharkhand), abiding by all the procedure as laid down in Cr.P.C and the latest guide lines of the Apex Court. As the offence is bailable, I offered him bail but none turned up before me. On being asked he refused to undergo medical check up. So finding no other any alternative I brought him to Santaldih I/C BCW under Santaldih PS along with seized articles.

Therefore I pray before you that a specific case may kindly be registered against the accused namely Ganesh Rajwar (26 yrs) S/o- Arjun Rajwar of Locoshed Para, Ward No-11, PS- Purulia(T), Dist-Purulia, P/A- Vill- Bhojudih (Nagarmajhidih), PS- Chandankiyari, Dist- Bokaro, (Jharkhand), (Driver of Black Pulsar Motor Cycle having Reg. No.- WB-56S-9167, Engine No- DHXRMH77806 & Chassis No-MD2B68BX5MRH41968) under proper section of law and arrange for its investigation.
