**Sub.: FIR for theft inside plant premises of STPS.**

At about 02:30 P.M on today i.e. 09.11.2022, 3 miscreants near Hopper area of Coal Handling Plant were found stealing some spare parts of machineries. The miscreants made unauthorized entry into the plant premises and as such they were chased by the security personnel of agency M/s Espy Protection Pvt. Ltd engaged by STPS authority. After chasing, the security personnel could catch only one and the rest two fled away. The nabbed one had in his possession with 3 rollers of hopper. Names: Kamal Bauri and Dulal Bauri, both from Poradih Village.


The written statement dated 09.11.2022 from the security personnel regarding the incident of theft which is self-explanatory.
