Sir.

In producing here with 36.83 M.T. coal brought at PS by various hired vehicle under proper seizure, I SI Shuvankar Sarkar, In-charge, Santaldih IC (BCW), beg to submit that during special mobile duty on 24/11/2022 at 19.25 hrs received a credible source information about illegal coal stocking at Ushir Jungle, near Kali Mandir under Santaldih PS . Accordingly I informed the matter to IC Santaldih PS and as per his direction, I along with C/1183 Subhas Kundu, C/29 Kousik Ghatak and being accompanied by evening mobile officer ASI Rabindranath Nag and force of Santaldih IC (BCW) vide Santaldih IC (BCW) C.C No. 1456/22 dated- 24.11.2022 and Santaldih IC (BCW) GDE No. 462, dated 24.11.2022 went out for executing the information. At about 20:05 hrs when we reached at Ushir Jungle, near Kali Mandir, we found that a huge quantity of steam coal is being stocked at this place. Seeing the Police party from a distance the persons present there were fled away from the spot. We chased them but could not able to intercept them. I searched the place and its adjacent area but no owner of the said coal turned up or nobody produced any valid document regarding the said coal. During local enquiry it is revealed that the coal was stocked by (i) Kartick Mondal, S/O Nandalal Mondal and (ii) Stakim Ansary, S/O Lt. Kurban Ansary both of Ushir, PS -Santaldih, Dist. - Purulia. The coal was approximately 33 M.T. After finding no other alternative I seized the coal approx 33 MT steam coal in between 20:15 hrs to 20:35 hrs under proper seizure list in presence of witnesses duly signed by them. As no public witness was available there hence only police witness have put signature on the seizure list. I have also seized 1 KG coal from the said seized coal as sample.

After that we arrange for transporting the coal from the PO and send to weigh bridge to weigh the actual quantity of coal by arranging local vehicles on hire. On its weighing it is calculated as 36.83 MT. After that we brought the seized coal at Santaldih PS and kept it at PS compound. On secret enquiry through my reliable source it came to light that the above noted persons have with their full knowledge running this clandestine business by means of stocking and selling or supplying of coal for their wrongful gain.

Hence I do here by lodge this complaint with a prayer that a specific case may be started against above noted (i) Kartick Mondal, S/O Nandalal Mondal and (ii) Stakim Ansary, S/O Lt. Kurban Ansary both of Ushir, PS – Santaldih, Dist. – Purulia under proper section of law and arrange for its investigation.
