Sir,

In producing here with seized approx 07 (Seven) M.T coal out of this 1(One) Kg coal seized as sample with proper seizure list. Today (20.11.2022) myself along with force C/79 Partha Sarathi De and NVF/768 Shiblal Majhi were performing mobile duty on Raghunathpur-Saltora road ( SH-08) and at about 14.25 hrs received a source information that some unknown miscreants were trying to dump coal illegally in a bushy area near at Mokra village. I informed the matter to O/C Santuri PS and as per his direction I along with force went there to work out the information.

Accordingly, I along with accompanying force reached that spot at about 14.55 hrs and found some coal dump in a bushy area near at Mokra village. I searched the surrounding area to trace out the owner of the dump coal but could not found any person to claim the same. After that we searched the spot and found approx 07 (Seven) MT coal was dump. Accordingly, I held local enquiry to know the involved persons to establish identity but failed. So, I seized approx 07 (Seven) M.T coal out of this 1(One) Kg coal seized as sample under proper seizure list duly signed by the available witnesses on 20.11.2022 in between 16.25 hrs to 16.45 hrs. It is reasonable to belief that those unknown miscreants dump the said coal in a bushy area near at Mokra village were engaged for extracting, lifting and transporting of illegal coal for clandestine business hatching a criminal conspiracy with a view to wrongful gain after forming a racket. So, the unknown miscreants are liable for committed offence punishable U/S 379/411/414/120B IPC & r/w Sec 30(2) CMN Act, 1973.

Therefore, I pray before you that a specific case may kindly be started against those unknown miscreants as per law.
