Sub: Complaint against Swapn Mondal (48 Yrs), S/O- Lt. Rakhahari Mondal of Vill-Bhagabandh, P.S - Santuri, Dist - Purulia to start a cog case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing here with the arrested accused person namely Swapn Mondal (48 Yrs), S/O- Lt. Rakhahari Mondal of Vill-Bhagabandh, P.S - Santuri, Dist - Purulia along with 07 liters 800 ml Country Spirit (13 bottles X 600ml) value of Rs- 55 X 13= 715/- seized under proper seizure list, I beg to submit that today (25.11.2022), I along with force while performing evening mobile duty at about 16:45 hrs received a credible source information that one person namely Swapn Mondal (48 Yrs), S/O- Lt. Rakhahari Mondal of Vill-Bhagabandh, P.S - Santuri, Dist - Purulia was stocking and selling Country Spirit without any valid license from his shop at Vill- Bhagabandh, P.S - Santuri, Dist - Purulia. Accordingly, I along with force reached in the shop of Swapn Mondal at about 16:55 hrs at Bhagabandh village to work out the source information and held raid there. I like to note here that seeing the Police personnel, customers were fled away. During search with the help of accompany force, we found that the said person was stocking Country Spirit bottles for sell. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of Country Spirit bottles. Accordingly, I seized and labeled 13 (Thirteen) bottles 'DIL SE' country spirit containing 600ml each bottle and amounting Rs-55/- (Fifty five) each bottle, Total amounting Rs- 715/- under proper seizure list duly signed by the witnesses out of which one bottle sealed and labeled as sample. Then, I arrested him after preparing proper arrest memo as he committed offence U/S- 46A(C) B.E. Act 1909 and supplied one copy to him.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S- 46A (C) B.E. Act 1909 against the arrested accused person namely Swapn Mondal (48 Yrs), S/O- Lt. Rakhahari Mondal of Vill-Bhagabandh, P.S - Santuri, Dist - Purulia.
